In exchange for receiving a TEACH Grant, you must agree to serve as a full-time teacher in a high-need field in a public or private elementary or secondary school that serves low-income students. As a recipient of a TEACH Grant, you must teach for at least four academic years within eight calendar years of completing the program of study for which you received a TEACH Grant. IMPORTANT: If you fail to complete this service obligation, all amounts of the TEACH Grants that you received will be converted to a Federal Direct Unsubsidized Stafford Loan. You must repay this loan to the U.S. Department of Education. You will be charged interest from the date the grant(s) was disbursed. Once the grant has been converted to a loan, it cannot be converted back to a grant.



I am a graduate student in my first semester at SVSU and have an undergraduate (UG) GPA of at least 3.25. After my first semester I must maintain a SVSU cumulative GPA of 3.25. (*Attach UG transcript*)

I am a transfer (undergraduate) student in my first semester at SVSU with a cumulative GPA of at least 3.25 on classes that were successfully transferred to SVSU. After my first semester I must maintain a SVSU cumulative GPA of 3.25. (*Attach UG transcript(s)*)

\_\_\_\_\_I scored above the 75<sup>th</sup> percentile on at least one of the batteries of the ACT, SAT or GRE.
