**2010 Filing Requirements for Most Taxpayers**

**2010 Filing Requirements for Dependents**

If your parents (or someone else) can claim you as a dependent, and any of the situations below apply to you, you must file a return. Earned income includes salaries, wages, tips, and professional fees. It also includes taxable scholarship and fellowship grants. Unearned income includes investment-type income such as taxable interest, ordinary dividends, and capital gain distributions. It also includes unemployment compensation, taxable social security benefits, pensions, annuities, and distributions of unearned income from a trust. Gross income is the total of your earned and unearned income.

If you were not age 65 or older or blind, you **must** file a return if **any** of the following apply:

- Your unearned income was more than \$950.
- Your earned income was more than \$5,700
- Your gross income was more than the larger of:
  - \$950, or
  - Your earned income (up to \$5,400) plus \$300.

**Certification:**

- I certify that my tax filing status is single, someone else cannot claim me as a dependent, and my gross income was less than \$9,350 (or \$10,750 if I qualify).
- I certify that my tax filing status is married filing jointly and that my combined income with my spouse is less than \$18,700 (or \$19,800 or \$20,900 if we qualify).
- I certify that my tax filing status is married filing separately and that my income is less than \$3,650.
- I certify that my tax filing status is head of household and that my income is less than \$12,050 (or \$13,450 if I qualify).
- I certify that my tax filing status is qualifying widow(er) with dependent child and that my income is less than \$15,050 (or \$16,150 if I qualify).
