## Cardinals earn GLIAC football honors

Six Cardinals were named to the Great Lakes Intercollegiate Athletics Conference first and second team. Sophomore OL Chad Lackowski and senior CB Demons Bryan earned first-team honors. Lackowski anchored an offensive line that helped the Cardinals average 157 yards rushing and 248 passing yards per game during the regular season. Bryan set a new GLIAC record for most interception return yards in a game (191) against Ferris State. He finished the regular season with 49 tackles and four interceptions.

Four Cardinals, including QB Matt LaFleur, RB Keath Bartynski, DL Antonio Sherrell, and LB Adam Wheatley were named to the GLIAC second team. SVSU also had five players earn GLIAC honorable mention, including WR Travis McAlpine, OL Shawn Curtiss, SS Pat Cavanaugh, LB Jason Battershell, and K Eric Houle.

The Cardinals' epic 25-point comeback against NCAA-tournament opponent IUP was documented on ESPN's *Hidden Video* segment.

## SVSU Commencement features Dow Corning executive

Dow Corning USA Corp. President Burnett S. Kelly will present the keynote address during Saginaw Valley State University's winter Commencement ceremony, Friday, Dec. 14. Kelly, also a member of SVSU's Board of Control, will discuss "The Best of Times."

Nearly 400 SVSU students are expected to participate in the University's Commencement program, which will take place in the O'Neill Arena beginning at 7:30 p.m., Friday, Dec. 14. The 388 people expect to complete degree requirements this semester and indicated they plan to don regalia and march in the ceremony.

They are part of a graduating class of 437 graduates that includes 331 who will receive bachelor's degrees and 106 who will be accorded graduate degrees.

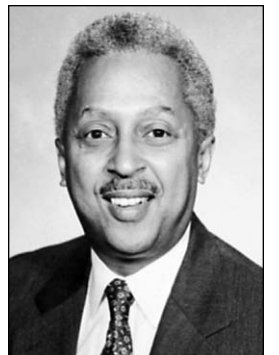
Gamal A. Elashhab, professor of educational leadership and services, will present the invocation.

Kelly, president of Dow Corning USA, joined Dow Corning in 1978 as a staff attorney. He served as manager of employee relations from 1985 to 1989, and became manager of the Hemlock Medical Plant in 1989.

Kelly was named manager of the Medical Materials Commercial Unit in 1991, and director of Human Resources and chairman of the Breast Implant Issue Management Team in 1992. In August 1993, Kelly became president of Dow Corning USA, and in December 1993 was named a corporate vice president by the Dow Corning Board of Directors.

Prior to joining Dow Corning, Kelly served as counsel to the chairman of the Equal Employment Opportunity Commission in Washington, D.C., and also worked in human resources for Chrysler Corp. His undergraduate degree is from Michigan State University (1966), and his juris doctor is from the Detroit

College of Law (1974). Kelly is active in many community groups and various Boards. Included is his contributions to SVSU as a member and past chairman of the SVSU Board of Control. He also is a member of the SVSU Board of Fellows. Other community service activities include the Board of Directors of Wolverine Bank; Board of Directors of the Midland Regional Medical Center; Board of Directors of the Midland Country Club; the Saginaw Valley Torch Club; Midland Foundation; and the MSU School of Education.

Saginaw Valley State University recently received a grant from the Michigan Department of Transportation to develop a non-motorized pathway on campus. The path will run from Phase I of University Village to the corner of Pierce and Bay roads, then continue north, parallel to Bay Road, across college drive to near the Beattie Pools property. The pathway will be a 10-foot wide paved path for recreational purposes. According to Steve Hocquard, director of engineering services, MDOT awarded the grant because the path will be part of a future non-motorized trail system that will run from Bay County to the Tittabawassee corridor. Hocquard said in 2002 MDOT will develop a new road from Pierce Road to the Tittabawassee corridor that will have a similar pathway. Work on the project has started. It is estimated the \$200,000 project will be complete in late spring 2002.

## Polish Students Club plans 25th annual *Wigilia*

The SVSU Polish Students Club will present *Wigilia*, a traditional Polish Christmas Eve, at 7 p.m. Friday, Dec. 14 in the Banquet Rooms in Curtiss Hall. The event focuses on the universal human brotherhood and is open to people of all races and faiths.

*Wigilia* comes from the Latin *vigiliare* and is the wait for the birth of Christ. This 1,000-year-old Polish tradition focuses on *Oplatki*, or wafers, which are placed on each table. *Oplatki* symbolize universal human brotherhood and are shared in order to emphasize mutual forgiveness and love of all people, regardless of race, gender or status. According to tradition, empty places at the table signify a willingness to welcome any guest; on that night any visitor, invited or not, is considered dear and special.

Before the dinner begins, the head of the household, with the *Oplatek* in hand, shares the wafer with those gathered while exchanging greetings and best wishes. All others do the same.

Following dinner will be a dance performance by the renowned Detroit-based group Wawel, named after the royal castle in Krakow.

Reservations for *Wigilia* are due Dec. 1. Tickets are \$20 for adults, \$10 for children ages 4 to 8; children under 3 years will be admitted free. 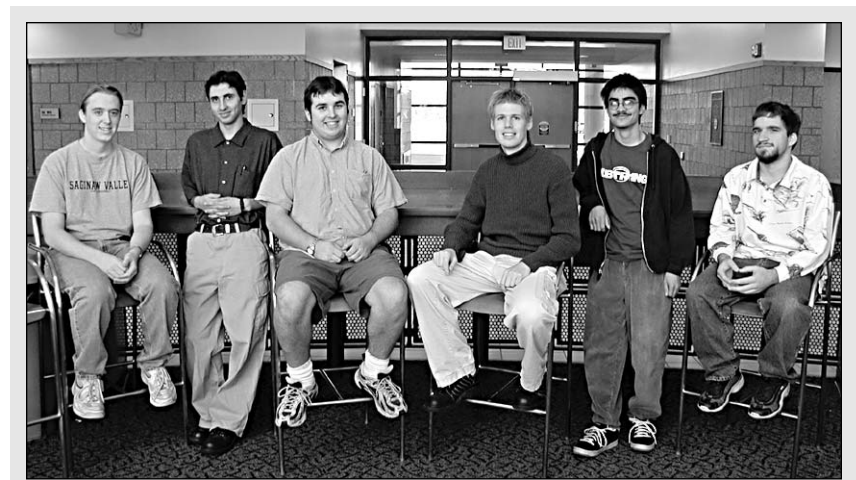
