ELECTION OF OFFICERS:

Groening pointed out that by statute a secretary and treasurer are required and that a chairman and vice-chairman are permissive. Most State colleges do not have bylaws.

BM-1 Brown felt that the Board must have a chairman as spokesman, and moved that the Office of Chairman of Board be established with chairman instructed to conduct meetings.

BM-2 Fox nominated Groening to serve as Chairman and moved that the nominations be closed and the Secretary be instructed to cast a unanimous ballot for Groening.

Groening abstained from voting.

TRANSITIONAL PROBLEMS:

It was reported that the Attorney General's opinion on the applicability of pledges has not as yet been received by Senator Hart. Chairman Groening with the President and Counsel will take appropriate action when opinion is received.

LEGISLATIVE SITE COMMITTEE REPORT:

A copy of the report submitted by Rep. J. Robert Traxler, Chairman of the House Special Committee on a site for the S.B.S.C., which read as follows, was distributed:

'This report is submitted in accordance with House Resolution No. 193 of the Legislative Session of 1965, which created a Special Committee relative to the selection and approval of a site for the Saginaw Bay State College.

The Com mittee conducted a public hearing in conjunction with the Senate Capital Outlay Committee in the Bay City, Saginaw area relative to selecting a site for the Saginaw Bay State College. Several members of the House Ways and Means Committee were also in attendance at the hearing.

After due deliberation, the Committee recommends approval of a site to be acquired within either Section 20, 21, or 22 of Kochville Township on the Freeland Road, in Saginaw County, as the location for the establishment of Saginaw Bay State College."

Groening recommended that before the State Board of Education is approached with the precise location, the following points should be considered:

- a.) Ask architects advice.
- b.) Study availability of utilities (water and sewage)
- c.) Ask Counsel to study township ordinance regarding present and future zoning.
- d.) Consult with Saginaw and Bay County Road Commissions regarding improvement of Freeland Road.
- e.) Consult with Airport Commission. State Aeronautics Authority may have to be consulted.

Brown suggested that the feasibility of using "University Center" as an address be investigated.

Curtiss suggested that federal representatives be informed of expressway problems.

BUDGET - 1966-67:

Marble reported that the budget for the State Department of Administration is due November 2, 1965, and requested a meeting of the S.B.S.C. Board of Control prior to that date. Mr. John Green of Budget Department is expected to come to University Center for a meeting on Tuesday, October 19, 1965. The following meetings of the Board were set up:
