#### I. CALL TO ORDER

Mr. Groening called the meeting to order at 10:25 a.m.

#### II. MINUTES OF PREVIOUS MEETING

#### III. REPORT OF PRESIDENT

#### A. Herbert W. Fox

The President reported the sudden illness of Board member, Herbert W. Fox, who is convalescing in Alpena General Hospital. His absence was noted and good wishes were extended for his speedy recovery.

#### B. Admissions

As of this date, 132 applications have been received for the 1968 fall term, of which 108 have been admitted compared to 91 with 69 admitted last year. This figure is not too far from what was anticipated in the budget.

#### C. Library

The President reported that the goal of 20,000 volumes has almost been reached as the March Library Report indicates that 19,394 volumes have been catalogued to date. Copies of the monthly report, as well as a chart indicating the rate of library acquisitions, were distributed.

### D. Business Administration Proposal

The proposal is being given further study.

#### E. Engineering and Health Science Proposals

A committee of scholars is being appointed by the State Board of Education to review these proposals.

A penetrating and favorable report on a recent study of SVC prepared by the Visitation Committee of North Central Association has been received, a copy of which will be given to each member of the Board.

#### F. General

Appreciation was expressed to Stuart Gross for his efforts in having SVC signs placed on major highways in the Tri-County area. Mr. Gross said that the Saginaw Road Commission has indicated that signs will be placed on the county roads.

It is expected that Provost Donald O'Doud of Oakland University will meet with the President of SVC and representatives of Dow Corning and The Dow Chemical Company soon to discuss the potential of a program in design.

A representative from Bolt, Beranek and Newman, a New York City firm offering theatre consulting services, will visit SVC to study design and feasibility of use of a theatre building.

#### IV. REPORT OF VICE PRESIDENT

#### A. Borrowing for Residence Halls

Mr. Driver proposed the following resolution to provide construction funds up to \$1 million for residence hall facilities.

Mr. Curtiss offered the following Resolution for adoption:

RES-37 RESOLVED, That pursuant to the authority given the board of control under Senate Concurrent Resolution 193, the Chairman or President and the Secretary or Treasurer are hereby authorized and empowered for and on behalf of Saginaw Valley College to negotiate and procure loans from any bank or banks as determined by the said board of control from time to time as they may deem necessary aggregating not to exceed \$1,000,000.00, for the erection and equipment of residence hall facilities on the principal campus of Saginaw Valley College, repayment thereof, together with interest thereon, to be made either from refinancing or out of the fund derived from renting or other income from the use and operation of the said properties, or from special fees or charges required to be paid by the students benefitted thereby; and to pledge all or any part of the fund as security for such loan or loans.

FURTHER RESOLVED, That said named officers are hereby authorized and empowered to execute and deliver such instruments as are necessary or desirable to fully effectuate the purposes of this resolution. This resolution shall continue in full force and effect and any bank may recognize the present authorized officers of Saginaw Valley College as authorized to act for it hereunder, until notice to the contrary in writing is received by any bank. #### Wesley Leuenberger, Supervisor of Kochville Township.

Mr. Leuenberger told the Board that at the present time Kochville Township is provided with fire protection by Tittabawassee Township at a cost of \$100 a run plus \$100.00 an hour for each additional hour. The Township feels that since SVC is not a tax-paying unit, the institution should pay for its own fire protection. Mr. Groening instructed the President to investigate the policy of other State schools located in township areas to determine whether municipal or township services should be paid by the institution.

## OLD AGE AND SURVIVORS' INSURANCE

## RESOLUTION

WHEREAS, The Social Security Act has been so amended by the Congress of the United States as to permit political subdivisions of the several states to extend to their employees and officers the benefits of Old Age and Survivors' Insurance, and

WHEREAS, The Michigan Legislature in regular session enacted Public Act No. 205, P.A. 1951, as amended, to enable the State of Michigan or political subdivisions thereof to secure coverage for their employees under the Old Age and Survivors Insurance provisions of Title II of the Social Security Act as amended, and

WHEREAS, An agreement has been entered into between the State of Michigan and the Secretary of Health, Education, and Welfare to extend the benefits of the federal Old Age and Survivors' Insurance system to employees of the state or of any political subdivision thereof.

THEREFORE BE IT RESOLVED, That the governing body of Saginaw Valley College Michigan, hereby elects coverage under the Old Age and Survivors' Insurance, as provided by Act No. 205, P.A. 1951, as amended.
