#### **III.** ADMINISTRATIVE REPORTS

The President said that for the first time the Board is meeting in the Board Room of the first permanent academic building on the campus of SVC. This is the moment that we have looked forward to for five years and it should be a very happy and important year for the college. We recognize that the number of new students on the campus is larger than returning students; the number of new faculty is larger than returning faculty, which means that all of us will have a lot to do in becoming acquainted. Early predictions indicated that there would be between 1,300 and 1,400 individuals registered for study for the fall term. The last figure was 1,287 and it is expected that with the evening enrollment there will be approximately 1,350 students.

## A. Budget Committee

Mr. Driver introduced Allan C. Orr who has been employed as Director of Cost Studies. His responsibilities will be to assist in understanding, evaluating, and recommending programs for the school. He is also assisting with the budget.

Mr. Zahnow presented a General Fund Operating Budget for 1969-70 with a gross total of \$1,085,700 for Board approval.
