C. Recognition of the Official Representative of the Faculty Association

Professor Robert Lane, President of the Faculty Association, told the Board that he has been a member of the College Success Program for just under 12 years. He noted: "There are really three aspects of the course. First, we try to help develop some basic skills among the first semester students in note taking, test taking, time management, etc. Secondly, we give them some knowledge about the campus and its resources The third aspect is to give them . . . guidance and life skills, such as how to navigate alcohol issues and what it means to be a college student. It's a way to help them make the transition to college. . . . Students who take the College Success Program tend to perform better academically than their peers overall, and their retention rate is also higher."

WHEREAS, The current students being served by Creative Learning Academy and Merritt Academy and their parents have requested the opportunity to provide prekindergarten education; and

WHEREAS, The Creative Learning Academy and Merritt Academy have a desire to provide an education service for pre-kindergarten students;

NOW, THEREFORE, BE IT RESOLVED, That the Saginaw Valley State University Board of Control approve the application and program amendment providing for the addition of pre-kindergarten students beginning with the 2009-2010 school year.

Dr. Schneider told the Board that the proposed pre-kindergarten programs would help increase

the population of the charter schools by which they were operated.

He noted that if a pre-kindergarten program applies to have a "Headstart" program, they must

follow the Headstart guidelines. If they have childcare, they must follow the Department of Social

Services guidelines for childcare. If they have a State program for pre-schoolers, they must follow

the Michigan Department of Education guidelines as well as childcare guidelines.

The motion was APPROVED unanimously.

WHEREAS, Mr. Graham is known in the community for civic engagement and as a consultant for several agencies. He was honored for his outstanding record of service by receipt of the Ruben Daniels Award for Community Service, the Faculty Award for University Service, the Professional Development Award from the American Chemical Society, and the Service to Society Award from the American Institute of Chemical Engineers. For his exemplary service and dedication to the University, he was named "Professor Emeritus of Mechanical Engineering" in 2005.

NOW, THEREFORE, BE IT RESOLVED, That the Board of Control of Saginaw Valley State University approve the granting of the Honorary Doctor of Science degree to Mr. Eldon L. Graham to be presented at the December 18, 2009 Commencement.

President Gilbertson told the Board that Professor Graham is a founding faculty member who

was very instrumental in the creation of SVSU's Engineering program. He has been extremely active

both on campus and in the community. Tony Ceccacci, speaker at tonight's Commencement, is one

of his protégées.

Jo Brownlie, Director of the Osher Lifelong Learning Institute (OLLI), told the Board that it had been eight years since she had met with them. At that time, OLLI had about 200 members – it now has over 1,200. OLLI, which was established in 2001, is an enrichment program for people over 50 years of age. It offers 200 non-credit short-term classes, as well as approximately 25 educational travel opportunities every year from day trips to international travel.

Kathleen Theiler Lanza doesn't need to read the latest"Themployment figures to know that many in Michigan are looking for
work. She sees them regularly as they seek to improve their prospects"have to

in a very competitive job market. "A lot of people, especially now, are coming back and saying 'I just got laid off. I need to do something to further educate myself.' We find out what their degree is in, and what they have been doing, and steer them in the right direction."

An SVSU graduate, Lanza never expected to become an employee. Of course, as a student the campus "looked a lot different," but now "it feels like coming home." She started working here in 2001 and recently became full time in graduate admissions, and her role continues to evolve.

"That's one of the things about my job that I really enjoy. It's not just putting applications in the system; I do application reports and enrollment reports. That took a little bit of educating. I like that the job changes; it's always growing."

Data entry is growing, too, as the number of graduate lications crossing Lanza's desk has increased 127 percent side fiscal year 2006. A surge in international interest is major contributing factor. Translating that interest into enrolled students often requires extra attention. "They have a couple more hurdles that we have to jump, because they have to make sure they can pass their visa process. Also, they have to pass requirements the federal government has for evidence of financial support; another hurdle is the language barrier."

Lanza said clearing those obstacles results in widespread benefits.

"The MBA program is one of the biggest that attracts international students," she said. "They're coming in from India, China, all over. That's great for SVSU, to have that international diversity. It's really good for the regional community and the economy, too."

Away from work, Lanza enjoys spending time with her siblings and activities with her son, Patrick, 10. Those include nature walks, bike rides, playing the piano and museum trips. She also likes to read and "anything with art."

Lanza describes herself as a "really organized person," which has aided the transition of working more closely with the College of Education in addition to her traditional colleagues.

"I'm working with some great people; it's a great team." And a winning one. "It's nice to see graduate admissions grow. To be part of that growth is pretty exciting."



STAFE MEMBER OF THE MONTH Darlene Seegert Administrative Secretary, College of Science Engineering & Technology • December 2009

Darlene Seegert has held the same position for 23 years and the One of Seegert's

same employer for 28; that experience pays dividends.

"No doubt about it," she said. "The longer you're here, the more you know what's going on."

With Deborah Huntley stepping into the dean's office this fall, Seegert says their prior experience together has proven valuable.

"The nice thing about that is that she was the acting assistant dean before, so we knew how each other worked. It's been a great transition."

That stands in contrast to when Seegert first started working in the College of Science, Engineering & Technology after previous posts in the Registrar's and Academic Support offices.

"You think you know a lot, and then you get in a position like the dean's office... my first year was so hard. That was the hardest job I've ever had. I was taking work home to keep up with things, but after that year, I got to know the ropes. I'm always up for a challenge."

Over the years, her responsibilities have remained similar, but not with meets them.

Technology-wise, it's changed a lot," Seegert said. "We used to sign a lot of overload slips by hand. Online class registration has really helped demand and reduced traffic through the dean's office." One of Seegert's favorite pastimes is joining colleagues across campus at noon for a game of volleyball or its cousin, wallyball, where the walls are in play.

"We've had a lot of fun with that. We've got quite a group. That's a great place to meet other people."

"It blows me away to think of what it was and what it is now. It was so worth the wait."

One constant in Seegert's career has been her appreciation for her employer.

"I love SVSU and I'm very dedicated to this place. My favorite part of the job is the people, working with the faculty and the students. It's just a good feeling when you know you can help somebody, and I've always enjoyed doing that."
