I. CALL TO ORDER

Chair Rupp called the meeting to order at 9:00 a.m.

II. PROCEDURAL ITEMS

A. Approval of Agenda and Additions to and Deletions from Agenda

B. Approval of the Board Minutes from the Regular Formal Session on October 24, 2022. It

C. Recognition of the Official Representative of the Faculty Association

Dr. Brandon Haskett, President of the Faculty Association, commented that the Student

Association and the Faculty Association hosted a collaborative forum on Friday, November 4. Professor Haskett stated that he enjoyed coordinating this event with the President of the Student Association, Austin Urlaub. He noted that the forum was a success, and the Faculty Association is looking forward to more of these forums in the future.

Professor Haskett offered congratulations to all the fall 2022 graduates. He commented that this is a special time for our students and their families. He added that it is also meaningful to faculty who have worked hard to get our students to this occasion.

D. Recognition of the Official Representative of the Student Association

Mr. Austin Urlaub, President of the Student Association, commented that the Student Association is busy reevaluating and reformatting some of their student government positions. He stated that these adjustments are necessary to meet the needs of students in a post-covid era.

1. Resolution to Grant Undergraduate and Graduate Degrees

WHEREAS, Operating Policy 3.101 Article III of the Board reserves to the Board the authority to grant degrees.

NOW, THEREFORE, BE IT RESOLVED, That the Board of Control of Saginaw Valley State University approves awarding the December 2022 undergraduate and graduate degrees as certified by the faculty and registrar for those students who completed degree requirements.

The motion was APPROVED unanimously.

2. Resolution to Approve Faculty Sabbaticals for Academic Year 2023-2024

3. Resolution to Grant Emeritus Status to Clifford Dorne

RES-2469 It was moved and supported that the following resolution be adopted:

WHEREAS, Saginaw Valley State University grants emeritus/emerita status to retiring faculty/administrators who have served the University with distinction; and

WHEREAS, Dr. Clifford Dorne arrived at Saginaw Valley State University in 1998 to join the faculty at the rank of associate professor, receiving the rank of full professor, and dedicating more than 24 years to the university until his retirement in August 2022, serving as Assistant and then Associate Dean for the College of Arts and Behavioral Sciences (2002-2006), Associate Vice President for Program Development and Graduate Admissions (2006-2010), University Registrar (2012-2022); and

WHEREAS, over the course of his career at SVSU, Dr. Dorne taught various criminal justice courses, including capstone and graduate courses for all criminal justice majors, as well as a corrections course where students toured the Saginaw Regional Corrections Facility while also serving the university as a full-time Administrative Professional; and

WHEREAS, Dr. Dorne was an active member of various organizations throughout his time at Saginaw Valley State University, including the American (and Michigan) Association of Collegiate Registrars and Admissions Officers MACRAO), Michigan Public University Registrars, National Association of Graduate Admissions Professionals, Association for Conflict Resolution, Academy of Criminal Justice Sciences, American Correctional Association, and Michigan Academy of Arts and Letters; and

WHEREAS, Dr. Dorne has served on a variety of university committees, including the Academic Dismissal Appeals Committee, Athletic Compliance Committee, COVID-19 Subcommittee on Reopening Campus- Student Experience/Student Services, Diversity Programs KCP Future Faculty Fellowship Committee; and WHEREAS, Dr. Dorne oversaw the office responsible for course registrations, academic records, State and Federal mandated reporting data, President's list data/certificates, assisted with transfer student processes, and was integral in the graduation process for students; and

WHEREAS, Dr. Dorne has consistently demonstrated a strong commitment and exemplary service to the University community.

NOW, THEREFORE, BE IT RESOLVED THAT Dr. Clifford Dorne be recognized as Professor and Registrar Emeritus.

The motion was APPROVED unanimously.

4. Resolution to Grant Emeritus Status to Eric DeVos

RES-2470 It was moved and supported that the following resolution be adopted:

WHEREAS, Saginaw Valley State University grants emeritus/emerita status to retiring faculty/administrators who have served the University with distinction; and

WHEREAS, Mr. Eric DeVos arrived at Saginaw Valley State University in 1991to join the faculty at the rank of assistant professor, receiving the rank of full professor in 2001, and dedicating 29 years of services to the university until his retirement in June 2020, serving on many committees and boards, including 20 years on the Institutional Review Board; and

WHEREAS, over the course of his career at SVSU, Mr. DeVos taught various psychology courses, including core and required courses for all psychology majors, as well as the capstone history of psychology course, which was conducted as an engaging seminar to challenge students to build sophisticated understandings of the origins and developing narratives of work in psychology; and

WHEREAS, Mr. DeVos held numerous topics areas of research involving student mentorship, such as The POUCH study, which included extensively collaborating with researchers at Michigan State University, the Thematic Apperception Test (TAT), which grew into a published multi-volume user manual co-authored with students, and with these various areas of scholarly work, and others, brought in grant money for SVSU, earned awards and recognitions, facilitated the professional growth of our students; and

WHEREAS, Mr. DeVos has shared his knowledge with the community: presenting to the Osher Lifelong Learning Institute (OLLI) on a variety of topics, such as Eastern traditions of mindfulness and Buddhist cultural teachings, as well as chaired the curation of the Saginaw on Stage local music event for which he's performed, organized, promoted, and raised money for various community entities.

NOW, THEREFORE, BE IT RESOLVED THAT Mr. Eric DeVos be recognized as Professor Emeritus.

The motion was APPROVED unanimously.

5. Resolution to Reappoint Auditors for the Fiscal Year 2022-2023

RES-2471 It was moved and supported that the following resolution be adopted:

WHEREAS, It is a good management practice to have conducted an annual independent financial audit; and,
