#### I. CALL TO ORDER

#### II. ACTION ITEMS

Chair Wiener stated that today's Special Formal Session was convened for the purpose of authorizing the execution of documents as required by the Michigan Liquor Control Commission to potentially take all actions necessary in connection with submitting applications for liquor licenses to be used at university facilities.

Trustee Cherry made a formal motion in favor of the proposed resolution. Trustee Crary supported the motion.

1. Resolution to Authorize the Application for Liquor Licenses at University Athletic Facilities

RES-2500 It was moved and supported that the following resolution be adopted:

WHEREAS, The State of Michigan in Public Act 96 of 2023 allows for the licensing of all Michigan public universities to sell alcohol on University property that is customarily used for athletic events and

WHEREAS, the University desires to execute documents as required by the Michigan Liquor Control Commission and to take all actions necessary in connection with submitting applications for liquor licenses to be used at University athletic facilities.

NOW, THEREFORE, BE IT RESOLVED THAT the Saginaw Valley State University Board of Control authorizes the President (or the President's designee) to take any and all actions and sign any and all documents on behalf of the University required by the Michigan Liquor Control Commission in connection with applying for a Class C or Tavern license to be used at the Ryder Center during events held at O'Neil Arena, the University Fieldhouse, Hamilton Gymnasium, and the Gerstacker Aquatics Center, and a Class C or Tavern license to be used at the University's outdoor athletic concession during events at Harvey Randall Wickes Memorial Stadium, and the University's soccer, lacrosse, softball and baseball fields, including but not limited to a corresponding University Athletic Facility License and Permit Application (Form LCC-116).

The motion was APPROVED unanimously.
