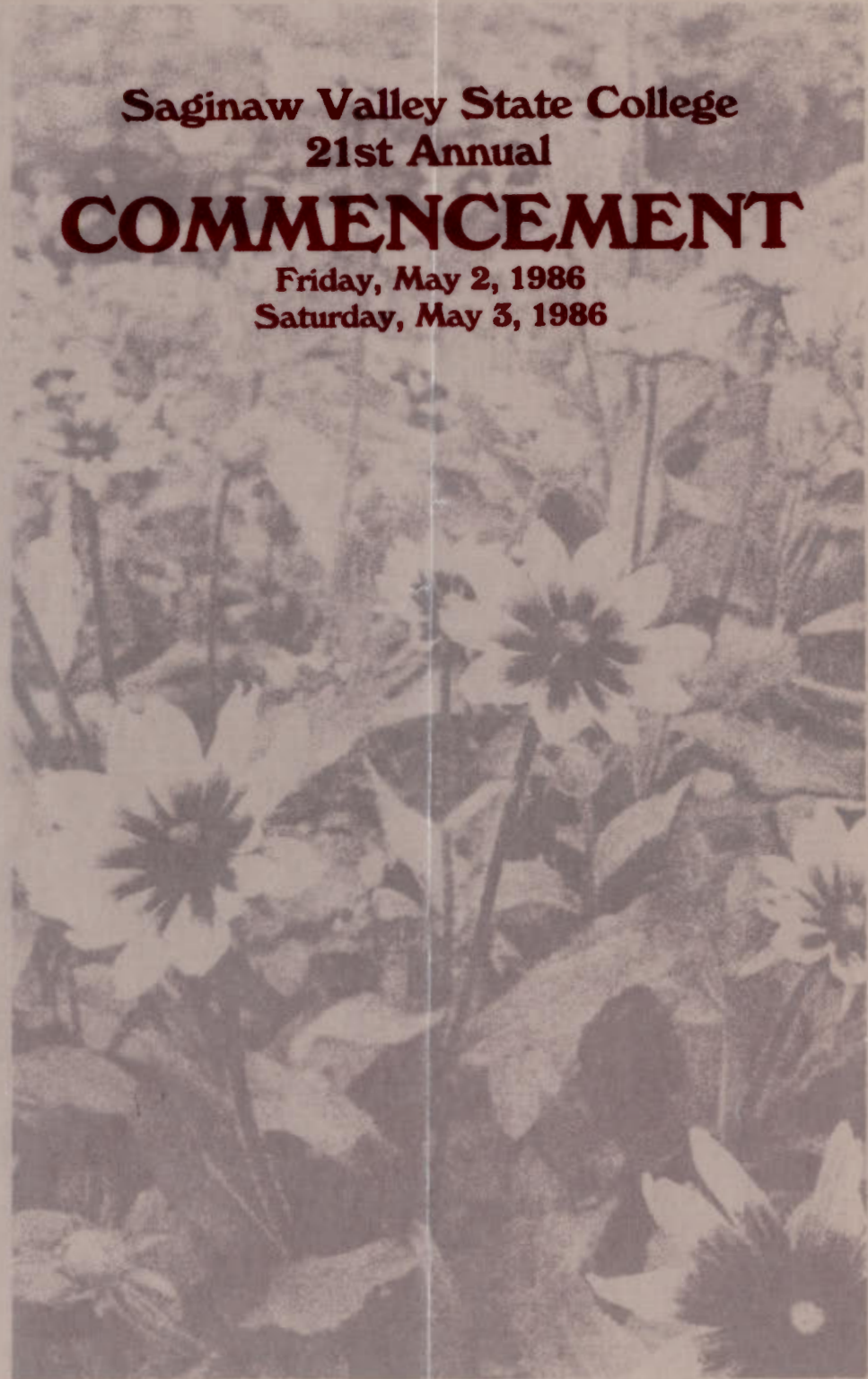

## CANDIDATES FOR HONORARY DEGREES



### DOROTHY D. ARBURY DOCTOR OF FINE ARTS

Dorothy D. "Honey" Arbury has played a major role in the development of Saginaw Valley State College. She assisted the College in its early struggles to become firmly established both academically and financially. Mrs. Arbury is one of two people who served on SVSC's governing board since the school's inception. After more than 22 years of service, she did not seek reappointment when her most recent term on the Board of Control expired last July.

Mrs. Arbury is a graduate of Kingswood School, and she attended Connecticut College for Women. Events surrounding World War II temporarily changed her priorities and she left college to become a "war wife." When not following her husband on various assignments, she worked as a teacher's helper in a private nursery school. She also worked in the Home Service Division of American Red Cross for two years.

Following the war years, Mrs. Arbury made her home in Midland, and was active in many civic groups. She served ten years as a member of the board of Midland Public Library. During that time the Grace A. Dow Library was planned and built.

She also served ten years on the advisory board of the Salvation Army and was instrumental in raising funds for a new building for that organization. She is a life member of the Contemporary Review Club, a women's study group.

Her interest in art led to a two-year term on the exhibitions committee of the Midland Art Council. She served on the Saginaw Art Museum Board of Trustees for two years and on their exhibitions committee for three years. She was the first woman to be appointed to the Board of Trustees of Cranbrook Academy of Art.

Her work on behalf of Saginaw Valley State College began during the College's first two years as a private school, 1963-65. When Governor George Romney signed the charter making SVSC a state college, she was appointed to its first Board of Control. She has been among the institution's most dedicated supporters, contributing time and energy as well as material resources. She took an active role in implementing the fundraising campaign that led to the construction of the Pioneer Hall of Engineering and Technology. More recently, she has provided key leadership for the Midland community committee seeking funding for SVSC's new Fine Arts Center, which will include the Marshall M. Fredericks Sculpture Gallery. She continues to serve on the Board of Directors of the SVSC Foundation.

Mrs. Arbury's concern for higher education is shared by her husband, Ned. President of A. S. Arbury and Sons, and active in many community organizations, Ned Arbury has been supportive of his wife's role at SVSC. He also has taken an active stance in supporting funding, both private and public, for higher education. He was recognized with an honorary degree from SVSC in 1983.

A native of Midland, Mrs. Arbury is a member of St. John's Episcopal Church. She is the mother of two grown children and has five grandchildren.

### JOHN W. KENDALL, III DOCTOR OF LAWS

John W. Kendall was born in St. Paul, Minnesota, and moved to Detroit with his family in December of 1940. He attended both parochial and public schools, but dropped out of high school in the tenth grade. For the next several years, he worked as a railroad porter in Canada and a factory worker in the Detroit area. He was drafted into the U.S. Army in 1952, and upon discharge returned to Detroit and his former job with Bohn Aluminum and Brass.

The need to continue his education became apparent, so he earned a G.E.D. and then attended several institutions of higher learning, earning credits towards a Bachelor's Degree. He received a B.S. in biology and education from Wayne State University in 1963 at the age of 32, and for the next three years taught science in the Detroit Public Schools.

In 1966 Kendall began working for Chrysler Corporation as a stamping foreman. During the twenty years since he joined Chrysler, he has held 26 different jobs in 14 locations. His areas of responsibility have included training, safety, communications, labor relations, minority dealership recruitment, personnel, and manufacturing. He currently serves on the corporate Industrial Relations staff. While employed by Chrysler, he has attended graduate school at Wayne State University and the University of Detroit. In 1978, with Chrysler's sponsorship, he completed the Executive Development Program at the University of Michigan.

Following the civil unrest in the late 60's, Kendall became committed to bringing racial harmony both to Chrysler and the community at large. During 1969 and 1970, he spent six months on loan to the "New Detroit, Inc." staff and still is a member of the Public Safety and Justice Committee. He also served several years on the Vickery Committee, appointed by the mayor and police commissioner.

In 1969 Kendall was appointed by Governor William Milliken to the Saginaw Valley State College Board of Control. His tenure began just as the school was dedicating its campus. During his 16 1/2 years on the SVSC Board, Kendall became well acquainted with each mile of expressway from Detroit to Saginaw. He attended countless meetings and rarely missed a major College event. He served as vice chairperson of the Board for seven years and chairperson for the past five years. He worked to help the people of the Saginaw Valley realize their desire for an institution of higher learning, and helped those directly connected with the school to carry out the building of that dream. He also served on the SVSC Foundation and is an active supporter of the Cardinal athletic program.

Kendall and his wife, Kathy, live in Southfield with their two children, Kristin and John IV, who are students at Southfield High School. Kristin will enter SVSC as a freshman this fall. Kendall's married daughter, Karen Hurley, attended SVSC as a freshman and sophomore.



### **JAMES R. KROHN** **DOCTOR OF LAWS**

James R. Krohn was born in Saginaw on December 11, 1924, and has been a resident of Saginaw all his life. His only extended period away from the city was for a three-year tour of duty with the U. S. Army during World War II. He served with distinction, and was awarded the Bronze Star for bravery in duty.

Krohn long has been active in the commercial and civic life of Saginaw. As president of Seitner's of Saginaw, he has experienced directly the changes that have taken place in the city and surrounding

communities. Under his leadership, Seitner's has maintained its reputation as a family-owned retail clothing store catering to the needs and tastes of local customers. Several years ago, Seitner's opened an outlet in Fashion Square Mall, and the original store on Federal Street continues to serve downtown Saginaw shoppers. There also are two Seitner's stores in Bay City.

Evidence of Krohn's commitment to improving the quality of life for area residents is found in his civic memberships. He is a member of Downtown Kiwanis and of the Saginaw Historical Society. He serves on the advisory board of the Saginaw Art Museum. He is a director for PRIDE - a community-based group working for "Positive Results in a Downtown Environment." He also has served as a director of Downtown Saginaw, Inc. and as director of Saginaw Central Area Inc.

Other community organizations have benefited from Krohn's involvement as well. He served a term as president of the retail division of the Saginaw Chamber of Commerce. He was a director of American Red Cross and chairman of "Service to Military Families" for Saginaw County and a vice president of United Way of Saginaw County. From 1966 to 1969 and again from 1971 to 1975 he was a member of the Board of Trustees governing Saginaw General Hospital. A member of Saginaw Club, he has served on its board of directors and as vice president of the organization.

In addition to his position with Seitner's, Krohn holds the presidency of the J. B. Sperry Co. of Port Huron. He also is a director of Second National Bank in Saginaw and served a term as president of the Central States Department Stores Association.

Krohn graduated from Saginaw High School in 1942 and received a Bachelor of Arts degree from Michigan State University in 1948. He is a member of the MSU Alumni Association and served as president of the MSU Alumni Association of Saginaw County.

Krohn and his wife, Barbara, have three daughters.

## **THE 1985-86 FRANC A. LANDEE AWARD FOR EXCELLENCE IN TEACHING**

### **SHYAMALENDU SARKAR** **PROFESSOR OF ECONOMICS**



Dr. Shyamalendu "Sam" Sarkar, recipient of the 1985-86 Franc A. Landee Award for Excellence in Teaching, joined the SVSC faculty in 1969. With nearly two decades of SVSC teaching to his credit, he has earned a reputation for simplifying the often complex theories underlying the study of economics. "He makes a difficult and confusing subject seem simple" and "Dr. Sam' has excellent rapport with his students, with the ability to inspire and motivate," are comments typifying student reaction to his instruction.

Sarkar served in a volunteer capacity as a foreign student advisor and he frequently counsels students on academic and other matters.

In addition to his teaching duties, Sarkar has completed extensive research. Much of his study has centered on agricultural marketing and economics and on the economics of health care delivery systems. He has published numerous papers, and many have been presented at conferences of professional societies and organizations. Most recently, he presented a paper titled "Comparative Study of Non-profit and Proprietary Hospitals" to the International Atlantic Economic Conference held in St. Thomas, U.S. Virgin Islands.

Sarkar has served on numerous college committees and study groups. Among his most recent assignments are the International Studies committee and the Health and Physical Education Complex committee. For six years he chaired the SVSC economics department. He participated in the development of SVSC's Master of Business Administration degree program and currently serves as MBA program director.

Sarkar also has been involved in many community groups. He is a member of Rotary International. His interest in health care has led to memberships on the board of the East Central Michigan Health Systems Agency, Inc. From 1981 to 1984 he was a member of the Statewide Health Coordinating Council appointed by the governor.

His professional memberships include the American Economic Association, the Health Economic Research Organization, American Agricultural Economic Association, Western Economic Association, Eastern Economic Association, Atlantic Economic Society, and Economic Society of Michigan.

Sarkar holds Bachelor of Science and Master of Science degrees from Ranchi University in Bihar, India. He earned a Ph.D. in agricultural economics from Michigan State University. Prior to coming to SVSC, he held various positions as an economist and research assistant at MSU and worked as a rural extension officer with the State of Michigan and foreign countries.

He resides with his wife, Priti, and their two children in Saginaw Township.

## THE 1985-86 AWARD FOR EXCELLENCE IN RESEARCH

### THOMAS J. RENNA PROFESSOR OF HISTORY



Dr. Thomas J. Renna joined the Saginaw Valley State College faculty in 1970. In addition to his excellent record as an instructor, Dr. Renna has amassed an outstanding reputation for scholarly accomplishments during his tenure here.

Among his achievements are the publication of two books, titled *Church and State in Medieval Europe 1050-1314* and *The West in the Early Middle Ages*. Currently, Dr. Renna is working on a third book, *The Jerusalem Connection*. The book centers on the idea of medieval thought as expressed in the modern-day Middle East.

Dr. Renna has had seven invited articles included in the *Dictionary of The Middle Ages*. Five of his pamphlets have been published by New Melleray Abbey, and more than 30 of his scholarly articles have appeared in refereed journals, including *Speculum*, *Citeaux*, *Augustinian Studies*, *Cistercian Studies*, *Studies Monastica*, and the *Michigan Academician*. In addition, Dr. Renna has read more than 35 papers at professional society meetings across the United States and abroad. In June of 1983 he accepted an invitation to present a paper at the History Conference on Learned/Popular Culture, 1300-1600, held at the University of Haifa in Israel.

His research has been assisted with funding from the National Endowment for the Humanities on two occasions, and twice has been funded by the American Philological Society. Other awards presented to Renna include the Distinguished Faculty Member, sponsored by the Michigan Association of Governing Boards; and Outstanding Scholar, 1983, presented by the Michigan Academy of Arts, Sciences and Letters. He is a member of Phi Beta Kappa.

Dr. Renna also has been recognized professionally by his peers at SVSC. He received the SVSC Merit Award in 1977 and has been awarded SVSC research grants on ten occasions. In 1984 he was presented the Landee Award for Excellence in Teaching, SVSC's highest honor bestowed on outstanding educators.

Renna, his wife, Pamela, and children reside in Saginaw. The Award for Excellence in Research recognizes faculty members who demonstrate scholarly work of the highest quality over an extended period of time.

## 1986 DISTINGUISHED ALUMNI AWARD

### DALE L. MOLITERNO, D. O.



Dr. Dale L. Moliterno was graduated cum laude from Saginaw Valley State College in 1975 with a Bachelor of Science degree. He earned a double major in psychology and biology while following an accelerated program that enabled him to complete degree requirements in less than two years.

In 1978 Moliterno graduated with honors from the College of Osteopathic Medicine and Surgery in Des Moines, Iowa. He was a member of Phi Sigma Gamma medical fraternity, and was selected as "Man of the Year" for that society in 1978. While in medical school, Moliterno conducted independent research on immune system induced glomerulonephritis in animals, using electron microscopy to conduct the study.

Prior to attending SVSC, Moliterno was employed by the American Foundation for Biological Research. He was directly involved in developing methods and techniques for freezing bones for bone grafts, blood cells for transfusion after frozen storage, and sperm cells for artificial insemination. He also helped initiate procedures for freeze-drying foods.

Since August 1, 1979, Moliterno has maintained a medical practice in Saginaw. He serves as a diplomate of the National Board of Examiners. He is Chief of Staff and a member of the Board of Directors for Saginaw Osteopathic Hospital. Among his committee assignments are chairmanships of SOH's executive committee and its quality assurance committee. He is a staff member at St. Luke's and St. Mary's Hospitals and is a member of the Board of Directors for Interlake Management Services, Inc. Other memberships include the Saginaw County Branch of the American Society of Blood Banking and the Saginaw City Riverfront Beautification Committee.

Moliterno has retained a commitment to education that includes service as advisor to SVSC students seeking admission to medical school. He is an associate clinical professor in Family Practice with the College of Osteopathic Medicine and a guest lecturer on anatomy and physiology for SVSC.

Dr. Moliterno and his wife, Marcia, have been married for 27 years. Mrs. Moliterno is a Registered Nurse and works in his office. Both serve as advisors to other physicians regarding medical billing practices. Their daughter, Brenda, graduated from SVSC's nursing program and now teaches nursing lab courses for SVSC. She also is a nursing supervisor at Saginaw Osteopathic Hospital.

## ACADEMIC REGALIA

Academic regalia of robe and hood are believed to have had their beginnings at the English Universities of Oxford and Cambridge during the twelfth and thirteenth centuries. The hoods are a carry-over from the times when the monks, who operated the universities, wore them to protect their shaved heads in winter or to collect alms when worn as shoulder capes.

Use of the academic robe came to the United States in 1754 with the founding of what is now Columbia University. In 1895 a commission of university officials adopted a universal code of design and color for academic garb that has undergone various revisions, the latest in 1960. Styling of robes varies for the bachelor's, master's, and doctoral degrees and the width of border and length of hood increase with the type of degree. The color of the velvet border of the hood indicates the field of study, while the lining designates the colors of the institution granting the degree. In the case of Saginaw Valley State College, the colors are cardinal red and royal blue.

The mace carried by the marshal in the academic processional symbolizes authority. This mace survived the 1985 Saginaw Valley State College fire.

## THE INSIGNIA OF SAGINAW VALLEY STATE COLLEGE

The geographical area formed by Bay City, Midland and Saginaw is represented by the triangle within the Saginaw Valley State College seal. This depicts the merging of three separate urban communities, with a combined population of more than 400,000, into the metropolitan Saginaw Valley.

The three symbols within the seal are of Egyptian origin. The figure at the top stands for life or living, denoting the fact that education is an ongoing, life-long process and has a value that lasts forever.

The symbol at the lower left represents light — perhaps the inner light. It recognizes that “our knowledge is a torch of smokey pine that lights the pathway but one step ahead.” Standing opposite this light of knowledge in the lower right corner is a staff, which stands for strength. This may be regarded as an appeal for the endurance necessary to search for and find the truth, and the strength to speak and live it.

The year of the College's founding, 1963, appears below the triangle.



**SAGINAW VALLEY STATE COLLEGE** was founded in 1963 as a private institution to meet higher education needs in east-central Michigan. It became state assisted in 1965.

Upper division classes in the liberal arts began in 1964 with just 119 students, but since then the College has experienced steady growth in enrollment and programs. Today, nearly 5,000 people from Michigan, several other states, and 20 nations are enrolled in more than 50 programs of study leading to bachelor's and master's degrees. International exchange and guest professors and students and an active international program bring the added dimension of other cultures to SVSC.

The primary mission of the College is to promote the intellectual and personal growth of students. SVSC also fosters research and creative activities. The goals of its research program are to extend knowledge, inspire superior teaching, and contribute to the intellectual, social and economic well-being of the region.

Community service is another element of the College mission. SVSC sponsors continuing education courses, conferences, workshops and technology transfer projects. Cultural events, many campus activities and the library are open to the public.

The completion of several construction projects, some of which are now in their final stages, will make SVSC one of the most modern and well-equipped centers for higher education in the nation. Scheduled to open this summer are a new science building, the Melvin J. Zahnow library, and Maurice Brown Hall (classrooms and faculty offices). A 40-unit two-bedroom College apartment complex welcomed its first occupants this winter. Groundbreaking for a new fine arts center is planned later this spring, with groundbreaking for a health and physical education complex to follow in the fall. A new Administrative Services Building replaced Wickes Annex, which was destroyed by fire April 24, 1985. Dedication ceremonies for the new building were held on Saturday, May 3, 1986.

The new buildings will provide resources for greater educational opportunities, not only for students working in SVSC's degree programs, but for the people of this community. Classroom buildings contain space for classes, conferences and seminars. The new science laboratories and classrooms will enable SVSC to offer such services as materials testing (on a contract basis) for local firms. Expanded library resources, including \$1,000,000 in new acquisitions over the next five years resulting from a gift by the Harvey Randall Wickes Foundation, will strengthen business database research as well as providing a place for research, study or reading and viewing enjoyment. The fine arts center, in addition to the studios, classrooms and rehearsal halls, will include the Marshall M. Fredericks Gallery, which will be a focal point for arts in the community. The gallery will contain models, drawings, photographs and bronze castings by this world-renowned sculptor. Also, it will have educational displays depicting the process of sculptural creation from the conception of an idea through the finished work. The health and physical education complex, in addition to classrooms, will incorporate, among other things, a dance studio, fitness and weight training areas, handball and racquetball courts, an aquatic teaching area with a swimming pool, an arena seating 6,000, basketball courts, an indoor tract, and several outdoor facilities, including a fitness trail to be completed in 1986.

While these added facilities are important assets in meeting the College's mission, the essence of a college or university is not brick and mortar, but rather the people who teach and learn within a building's walls. The employment and retention of highly qualified teaching professionals to its faculty and support staff is a primary goal for the College.

Americans appreciate and value learning. The number of adults participating in organized learning has risen dramatically in recent years. Furthermore, both public and private support for education has increased since 1984.

These added resources and new physical facilities, coupled with the commitment of SVSC personnel to meet the needs of the Saginaw Valley region, promise a bright future for the College and the people it serves.
