Dr. John R. Willertz, 531 Handy Drive, Bay City, is Associate Professor of History and Mayor of Bay City. He came to SVC in 1968. He was a Fullbright scholar, and did his doctoral thesis on local government in Nazi Germany. He earned his Bachelor of Arts degree at the University of Detroit, and his Master and Doctoral degrees at the University of Michigan.

Dr. Peter J. DeJong, 3508 Spicer, Saginaw, is Associate Professor of Biology. He joined the SVC faculty in 1968, and is Chairman of the Biology Department. He earned his Bachelor of Arts degree at Hope College, and his Master of Science and Doctoral degrees at the University of Wisconsin.

Dr. Curtis L. McCray, 1909 Coolidge, Saginaw, is Dean of the College of Liberal Arts. He joined the SVC faculty as an English professor in 1970. He earned his Bachelor of Arts degree at Knox College, and his Doctoral degree at the University of Nebraska.
