SPORTS SHORTS

Coach Frank "Muddy" Waters has termed SVC's first season of intercollegiate football a great success. The team played 12 games in 7 weeks.

Competing primarily against junior varsity-caliber teams in scrimmages, the Cardinal "red shirts" and top players finished a six-game winning streak by defeating Northeastern Illinois University Saturday, 27-13. The victory raised the team's record to 6-2 in scrimmages, and 8-4 overall, with the addition of the four junior varsity team which finished 2-2.

Waters and his staff are about to begin an extensive recruiting program to add depth and fill the weakness of the solid core they now feel has been established to bolster the team's chances of success in 1975.

Next year the Cardinals will compete as a regular varsity team in the Great Lakes Intercollegiate Athletic Conference, and have an 11-game schedule which is yet to be completed.
