CAMPUS NOTES

Late registration, which ends Friday, is expected to swell the winter semester enrollments, presently standing at 2,890 students and 28,057 credit hours. Last winter the college enrolled 2,555 students with 25,123 credit hours.

"Musical chairs" will continue this week as efforts are made to complete the move of administration, faculty, admissions, and registrar as smoothly and quickly as possible.

The mobile units are now occupied by Dr. Walter James, Dr. Russell Driver, Dr. Curtis McCray, Stuart Gross, and Dr. Guy Lee, Affirmative Action Officer.

Admissions will start its move to the mobile units on Wednesday. The Registrar's Office will move into the former admissions space, and the present registrar's office will be converted into faculty offices.

Other moves put Dr. Harold Peterson into Dr. McCray's former office, and Dr. George Harmon into Dr. Driver's former office. Dr. Larry Collins will move into Dr. Ryder's office as soon as Dr. Ryder is moved into the mobile units.

When the registrar's office takes over the present admissions area, a wall separating the area from the faculty offices will be built. Doors opening onto the admissions area will be closed off, and new doors constructed opening onto the former administration area. Mrs. Louise Ferris and Mrs. Elizabeth Gibson will continue to occupy their present offices.

The work of last semester's photography class, taught by Curt Leece of The Saginaw News, will be on display in the Arts Workshop January 5 through 19. Leece said the class is the best he's ever had.

The art students' annual printmaking exhibit will be held at the Saginaw Art Museum January 9 through February 13. The exhibit, which will cover the entire second floor of the museum, will feature etchings, aquatints, silkscreens, and block prints. The opening reception will be held this Friday from 6:30 p.m. to 8:30 p.m.

Barron Hirsch, professor of art; two art students, Mary Hart and Martha Yeatman; and James Chase, director of the Saginaw Art Museum; appeared on WEYI-Channel 25's Valley Today, where they discussed the upcoming printmaking exhibit.
