## NEW TRACK ON HORIZON FOR SVSC RUNNERS

Thanks to a \$150,000 donation by Morley Brothers Foundation of Saginaw, SVSC track and field participants will soon be running on a new outdoor, all-weather track. The College Board of Control yesterday cleared the way for the new facility, voting to begin construction as soon as the project is approved by a joint action of the state House and Senate.

The entire project, which includes a new baseball field and two softball diamonds, will cost an estimated \$310,000, of which \$240,000 in pledges has already been received by the SVSC Foundation. The track will be the area's first college-level metric facility and will be named Morley Field in honor of the principal donor.

## TUITION TO INCREASE FOR 1978-79 SCHOOL YEAR

In other action approved by the Board of Control yesterday, tuition and fees for the 1978-79 school year will increase by an average of \$15 per semester, based on an average course load of 10 semester hours of credit. Tuition was raised from \$23 to \$25 per hour; and the facilities fee was increased from \$1 to \$2 per hour, with a ceiling set at \$12. The fee increase, designated as "transportation use fee", will allow the college to eliminate the parking toll gates and the \$14 student parking permit fee. The College will still maintain reserved lots for faculty, staff, and handicapped parking.

## GENERAL FUND EXPENDITURES CONTINUE TEMPORARILY

The SVSC Board of Control Monday took steps to assure continued operation of the College in case the legislature fails to pass an operating appropriations bill for state colleges and universities before the current fiscal year expires June 30.

The Board voted to continue using General Fund money at the current level to cover necessary expenditures, such as salaries, wages, and supplies and equipment costs, until the appropriations bill is passed and the Board can adopt an operating budget for the next fiscal year.

The next Board of Control meeting was tentatively set for July 17.

#### OFFICE OF THE PRESIDENT EVALUATED

The scheduled evaluation of the Office of the President at SVSC will begin this summer at Dr. Barry Munitz, chancellor of the University of Houston, begins interviewing persons representing a cross-section of the college community.

Acting as a special consultant to the Board of Control, Munitz will conduct a round of interviews in late July and another in late August. He will prepare an evaluation to present to the Board at the end of September.

The evaluation, which was requested by Dr. Ryder when he became president in 1975, is intended to provide a usable framework for positive interaction between the Board and the Office of the President and to help both parties define their roles and responsibilities in handling the affairs of the college.

Such evaluations are becoming increasingly more common in colleges and universities throughout the country, as administrators seek objective feedback on their performances.
