All sessions will be held in the Wickes Hall Boardroom except for the Friday, December 15 meeting, slated for the Wickes Lecture Hall at 1:30 p.m.

PROCEDURE ESTABLISHED FOR CARDIAC EMERGENCY

A portable oxygen tank and ambu (manual respirator) are now available for use on campus in case a cardiac emergency occurs at SVSC.

The portable oxygen tank is stored at Student Health Service in B-2, Great Lakes Hall, and the Ambu (manual respirator) is stored in the Department of Public Safety's patrol car. Public Safety personnel have been instructed in the proper use of this equipment.

CONCERT CHOIR RECRUITING NEW MEMBERS

If you've always wanted to make beautiful music, the SVSC Concert Choir wants you! According to Dr. Eric Nisula, assistant professor of music and new conductor of the SVSC group, a trained voice or extensive singing experience are not necessary.

"All that matters is that you are sincere in wanting to make music -- I will take care of the rest! The real payoff is when your life is immeasurably enriched by coming closer to the works of Mozart, Bach, Beethoven,

or Brahms, either as a singer, audience, or conductor," Nisula feels.

There will be openings in all four sections of the choir, beginning with winter semester in January. Prospective members need not be enrolled in other SVSC courses to participate, and students of all ages are welcome. All one needs is a love of music, free time on Tuesdays between 12:30 and 1:30 p.m., and Thursdays from 12:30 to 2:30 p.m. and possibly a cassette tape player. "This is a great aid in learning parts," Nisula adds.

The Concert Choir is planning a major performance on Palm Sunday Evening, April 8, at St. Thomas Aquinas Church in Saginaw. Their musical Vespers service will feature a single work, the "Vespers de Dominica" by Wolfgang Amadeus Mozart, with soloists and a professional orchestra providing accompaniment.

-- Dr. Thomas Renna, associate professor of History, presented a talk on Thomas Merton as Peacemaker at the 4th National Assembly of Pax Christi USA: International Catholic Movement for Peace, on December 2 at Columbia University, New York. This was the seventh paper on the topic of peace read by Renna at various historical conferences around the country during 1978.

-- A short story entitled "Una Historia Real", written by Dr. Ricardo Pastor, associate professor of Spanish, was printed in the November 1978 issue of "Spanish Today". The magazine is published by Cruzada Spanish Publications in Miami, Florida. Dr. Pastor is a member of the periodical's Editorial Board.

-- Dr. Laczek Jarecki, research fellow at the Midland Macromolecular Institute, spoke on "Politics in Eastern Europe" at the Tuesday class session of the Eastern European political science course presently being taught by Dr. Anna Dadlez, assistant professor of Polish and

director of the Institute of Polish Studies. Dr. Jarecki, who specializes in ultra-high modulus polyethylene, is representing the University of Warsaw and the Polish Academy of Sciences during a one-year research assignment in Midland.

-- Dr. Shiv K. Arora, associate professor of marketing, addressed the Saginaw YMCA Retired Men's Fellowship Club on Monday, December 11 concerning "Economy and Free Enterprise". The senior citizens are probably the most affected by the state of the economy and were pleased to note that SVSC is doing something to promote free enterprise, Arora said. Over 60 members were in attendance, and presented him with a certificate of appreciation.
