#### HALLOWEEN EXTRAVAGANZA BRINGS 'DEVIL' TO SVSC

From the earliest days of human evolution, the force of evil has been recognized and feared. Whether called Satan, Lucifer, Beelzebub or a more folksy Old Ned, the Devil has been considered the personification of evil. He is feared, perhaps respected, but seldom understood.

"The Devil You Say...?", written and performed by Scott Keely, attempts to reveal the nature of evil. The one-actor play is scheduled for presentation at the theatre at 8:00 p.m. tonight (Tuesday, October 27).

Using a conversational format, Keely presents the "Devil's side" of the story. He challenges the audience to look beyond the confines of mortality. Woven into his portrayal are humor and suspense, truth and ambiguity. Keely includes excerpts from the Bible, plus such well-known authors as Mark Twain, Milton, Dante, Dostoevsky and Melville, to illustrate his point of view.

The result is not only entertaining, but also thought-provoking and educational. Keely feels that burgeoning technology makes it imperative for man to deal with and overcome evil. His show is an effort to explore this dark force and meet its challenge.

Keely, a professional actor for more than ten years, has worked extensively throughout the country. He has acted, written and directed for the stage, educational television and radio. His appearance at SVSC is sponsored by campus activities office

#### BOARD CALLS SPECIAL MEETING

A special meeting of the SVSC Board of Control has been slated for Thursday, November 5, at 1:00 p.m. in the Pioneer Room of Pioneer Hall. The two topics to be considered at that time are how the college will cope with last week's executive order, cutting \$221,787 from the current state appropriation and possible ratification of the new contract recently negotiated between the college and the Secretarial/Clerical Association.

Next regularly scheduled meeting of the full Board will be at 9:30 a.m. on Monday, December 14.

## QUESTIONS FOR THE EXECUTIVE COMMITTEE

Q. With the U. of M. leaving campus, I don't know if anyone has decided what will be done with their office space. We're really jammed in together here and are wondering if it might be possible for us to obtain their space?

Our office sure could use some "side" chairs for guests to use at meetings here. Could we get some of the furniture that CMU, UM and MSU are leaving behind?

A. The temporary unit being vacated by CMU, MSU and U. of M. will become the new headquarters for SVSC's Bilingual/Bicultural Education Center, which will move there after the U. of M. discontinues its Saginaw operation and CMU and MSU go to the downtown Saginaw Ruben Daniels Life Long Learning Center. Space in the unit being vacated by the Bilingual/Bicultural Center will make possible the addition of several classrooms for winter semester.

Office furniture and other items owned by SVSC but rented to the other colleges will be returned to central stores and placed in inventory for redistribution to the campus. Requisitions for equipment must be approved by your vice president if a cost of \$200 or more is involved.

If you are seeking equipment which has a less than \$200 cost, you have the option of either taking this money from your 400 block and having the business office transfer it to the 300 block of your budget or you may submit an equipment budget requisition to your vice president which, if approved by the president, would provide additional money from the overall college budget for transfer to your department. A college policy change reported in the "Interior" recently has given departments the authority to purchase equipment costing less than \$200, where the source of funding is to be from their 400 block budget. Previously the maximum allowed had been \$100.

Q. Now that October 1 has come and gone, I'm wondering if the Voluntary Group Life Insurance program received enough interest to go into effect.

A. A sufficient number of applications were received so that the Voluntary Life Plan will be implemented, effective November 1, for all

employee groups eligible for the coverage on October 1. Because the secretarial/clerical proposed contract has not yet been ratified, we do not know at this time when members of that group will become eligible for the coverage.

Q. We walked into our Wickes Hall office today and it was 90 degrees! The stairwell doors are now open to help eliminate the heat, and our office is now 68 degrees. Since when does SVSC heat the outside? What about the energy crisis? With state revenue being slashed, can we really afford this massive waste? I sincerely hope that Wickes Hall can someday be regulated in heating and air conditioning!

A. While this does not answer the question or provide an excuse for the high temperature which did, in fact, exist in Wickes Hall on Monday, October 19, it is important to realize that uniform temperatures throughout a structure that large are difficult if not impossible to maintain. Check with friends who work in large buildings at other colleges or at commercial structures such as Plaza North in Saginaw. SVSC now has a full-time staff member to monitor temperatures and make all adjustments possible to insure that working and classroom conditions are as uniform (and comfortable) as possible across campus. The problem on the 19th resulted from a breakdown of the main air compressor in Wickes Hall. This compressor runs regulators throughout the building by maintaining air pressure in thermostats, control valves, and all dampers for fresh and mixed air. When there is no pressure in the control system from the compressor, the whole system is normally open. The main compressor failed at about 4:00 a.m. Sunday night and steam lines and the main control valve were wide open as a result until 7:30 a.m. Monday morning, when the plant services staffer arrived on duty for the day. All doors were then opened and both return fans were turned on to alleviate the problem. Steps are being taken to prevent this situation from occurring again.

Whenever you become aware of situations where closer monitoring of temperatures would be helpful or where winter temperatures are allowed to exceed 68 degrees Fahrenheit, you are encouraged to contact the College Energy Conservation Committee through chairman Dr. Alistair Brett at ext. 4144.

#### WINTER CLASSES NOT FAR AWAY

SVSC students can choose from an expanded selection of classes when winter semester registration begins on Monday, November 9. Two additional mobile classroom units are being added to accommodate the extra winter offerings.

The added facilities will allow for six to eight more sections of popular evening classes, according to SVSC scheduling officer Liz Kornacki. Increased daytime offerings are also planned, and a criminal justice course will be taught on Saturdays for the convenience of students who work during the week. "Advanced Criminal Investigation" will meet every other Friday evening and Saturday morning beginning January 15.

College administrators point out that increasing enrollments at SVSC make it necessary to schedule classrooms to capacity. "Many of our students work part or full time and commute to campus. Thus we try to adapt to their schedules by offering numerous classes late in the afternoon and in the evening," Kornacki notes. She adds that courses are being offered at Arthur Hill high school and various sites in Caro, Cass City and Midland for the convenience of students living in those areas.

SVSC's electronic teleteaching system is also seeing increased use to provide college courses in Oscoda and Cass City. Students living in the Thumb area can select from nine teleteaching classes plus five on-site courses, for a total of 14 offered in Cass City. SVSC's Wurtsmith/Oscoda Center has scheduled 21 courses with nine by teleteaching and 12 on-site sections.

On-campus advanced registration is scheduled by class level, beginning with seniors, from Monday, November 9 through Wednesday, November 11. Open registration takes place on Thursday, November 12 and continues Monday through Wednesday, November 16-18. Other registration periods are set for Wednesday and Thursday, December 16 and 17, and Tuesday and Wednesday, January 5 and 6. To request

Visitors can watch actual classes in session at Cass City, which are connected by the electronic blackboard with "live" sections of the same courses on the main campus.

NEW LIBRARY CIRCULATION RULES AND REGULATIONS  
NOW IN EFFECT

Following approval earlier this year by the College Library Committee, Council of Deans and Directors and by the Executive Committee on May 13, new library circulation rules and regulations have gone into effect this fall semester for students, staff and faculty. Current College Library Committee members for 1981-82 and the units they represent are: arts and behavioral sciences - Dr. Thomas Renna and Matthew Zivich; business and management - Wayne Mackie; education - Dr. Susan Emond; nursing and allied health sciences - Margaret Flatt; science, engineering and technology - Dr. Arthur Andrewes; library - Rosemary Rice-Billings, secretary pro tem; Dr. Michael Lee, ex officio.

Under the new library circulation rules and regulations, SVSC faculty and staff members may borrow library and audiovisual materials subject to 1) return on or before one week after the next semester begins if materials are borrowed during the fall or winter semester, or two weeks after the summer session ends if borrowed during spring or summer session, or 2) recall by the library if the material is requested by another person after an initial three-week period. Faculty and staff are otherwise extended semester-long loan periods on most materials.

An overdue notice will be sent nine days after the due date. If materials are not

returned 21 days after the due date, a bill will be sent.

Subsequent to second notices being sent, borrowing privileges will be withdrawn if materials are still overdue and the director of library and learning resources will then notify the appropriate dean or vice president concerning delinquent accounts. If items still are not returned, an appropriate deduction may be made from an individual's payroll check. If such a deduction is necessary, library privileges automatically will be suspended and the individual involved must re-apply for privileges.

Faculty and staff members terminating their employment with the college must have settled any obligations to the library before receiving a final paycheck. Such clearances granted via the termination checklist, which is routed to the library/learning resources center.

Before leaving on sabbaticals, SVSC personnel should arrange with the director of the library/learning resources center to retain any library materials which they will require to complete sabbatical activities.

Faculty and staff members with existing library privileges will not become subject to the payroll deduction method described above, until and unless failure to comply with library obligations produces a suspension of privileges and makes necessary a re-application.
