SVSC NAMES EXECUTIVE DIRECTOR OF DEVELOPMENT

Dr. Albert J. Beutler has been named Executive Director of Development at SVSC. He also will serve as executive director of the SVSC Foundation.

Dr. Beutler's appointment is effective August 1. He will direct the college's fund raising activities, and will develop, recommend and implement policies and procedures related to fund raising. His duties include supervision of personnel responsible for coordinating annual funds and special projects, alumni and special events, and corporate relations and athletic development. He will report directly to the college president.

Beutler comes to SVSC from the Bethel Publishing Company of Elkhart, Indiana, where he served as the general manager and chief executive officer. Bethel operates four bookstores, a printing division, a wholesale operation, and a religious education materials division.

Prior to managing Bethel Publishing, Beutler served as president of Bethel College in Mishawaka, Indiana. During his tenure there, the college eliminated an accumulated operating deficit of \$250,000, constructed several new campus facilities, created new degree programs and initiated a curriculum review process.

Before his presidency at Bethel, he held positions as dean of students at Indiana University at South Bend and at Bethel College. He was promoted to associate professor of psychology and religion while teaching at Bethel College early in his career.

Beutler received a bachelor of arts in biblical literature and psychology from Bethel College. He earned a master of arts in biblical literature from Winona Lake School of Theology in Indiana, and holds a Ph.D. with a major in administration in higher education from Michigan State University. He has completed several research projects in higher education.

His professional memberships include the American Association for Higher Education, Council for the Advancement for the Support of Education, the Independent Colleges and Universities of Indiana, and the Indiana Conference of Higher Education. He was named "alumnus of the year" by Bethel College in 1966, has been listed in "Who's Who in the Midwest," and received the "Sagamore of the Wabash" award from the governor of Indiana in 1979. He has served on the United Way of St. Joseph County, the Junior Achievement of Michiana board of directors, the South Bend-Mishawaka Area Chamber of Commerce board of directors, the Michiana Arts and Sciences Council, and the Bethel College board of directors. He currently is a member of the State Student Assistance Commission of Indiana.

In announcing the appointment, President Ryder said, "We are pleased to welcome Dr. Beutler to our campus. His background includes experience during a period of rapid growth at Indiana University at South Bend and at Bethel College. This will be an asset as he assists with the development now taking place at SVSC.

"SVSC began as a private institution and has continued to receive generous support from private sources. Dr. Beutler's role in coordinating and developing private support will be extremely important, in light of SVSC's rapid growth and the limited State appropriations over these past five years."

Beutler said he looks forward to the challenges of his new position. "SVSC is an institution with a promising future. I am excited about the prospect of working with campus and community leaders to assist the college in its efforts to meet the needs of the people it serves."

The directorship of fund raising and the SVSC Foundation had been held by Dr. Ryder on an interim basis since the retirement of Dr. A. Jefferson Sharp.

FOOTBALL CAMP AT SVSC



SVSC EMPLOYEES COMPLETE COMPUTER TRAINING WORKSHOPS



BOARD REPORT



A Report of the Saginaw Valley State College Board of Control

May 10, 1985

Board of Control members agreed to hold a special meeting in July to set tuition rates for the upcoming school year. Noting that the state legislature is expected to complete final action on its 1985/86 appropriations bill early in July, President Ryder recommended delaying action on tuition rates.

Dr. Ryder outlined legislative action to set funding for SVSC and other Michigan colleges. "Governor Blanchard's proposal recommended an increase of 13.3 percent for SVSC," he said, "but that proposal contained \$500,000 for the start-up costs associated with the completion of I.F. 2. With that sum deducted, our actual increase would be only 7.6 percent compared to a 13 percent figure for those schools without similar costs.

"The House basically followed the Governor's recommendation," he continued. He pointed out that in 1979 SVSC lagged 11 percent behind the average for all Michigan colleges and universities in appropriations per fiscal year equated student. By 1984/85, after several years of enrollment growth here coupled with across-the-board percentage adjustments in appropriations, SVSC was 32 percent below the system average.

While commending the Governor and the legislature for steps taken to restore funding to higher education, Dr. Ryder noted the system is 11 percent below 1979 levels of support when inflation factors are considered.

Dr. Ryder said the Senate has recommended a total increase of \$115 million, bringing higher education's share of the 1985/86 budget to \$961,400,000. That was approximately \$10.4 million over the House version of the appropriations bill. Included in the Senate bill is \$2 million to be distributed

on the basis of enrollment growth. Based on a ten-year average of enrollment patterns, appropriations would be increased by \$260 per fiscal year equated student for those schools with increased enrollments. SVSC would receive \$308,000 from this source. Total appropriations to SVSC in the Senate bill would be \$10.5 million in 1985/86. The Governor's proposal, as well as the House bill, would send \$9,902,000 to SVSC.

Dr. Ryder stated that some tuition increase would be necessary with either bill, but that the level of increase could be contained under the Senate bill. He told Board members that several other Michigan colleges already have announced tuition increases, and others plan to do so. In most cases, the increases will be at the rate of inflation or less.

Student Government President Dan Strasz reminded Board members that SVSC students had accepted tuition increases some 15 times in the college's history. He pointed out the uniqueness of SVSC students, commenting that half are 25 or older, and that many have families to support. He said students would want a complete explanation of the necessity for any increase in tuition.

Board members devoted considerable time to the discussion of rental rates for the new apartment units to be constructed by fall semester. Rates proposed by the administration were set at \$360 per month for a two bedroom unit rented to married students. Single students would pay \$150 each per month to live in the units, with up to four students in each unit. In presenting the proposal, Vice President for Administration and Business Affairs Jerry A. Woodcock said the recommended rates were based on a survey of local rates for comparable apartments, plus the need to structure a revenue stream to finance the buildings.

Board member Charles Curtiss proposed changing the language of the resolution to read "family" instead of married, and "individual" instead of single to recognize situations such as a single parent with children. The resolution was approved as amended, with college administrators charged to work out appropriate contract wording and procedures.

The Board granted authority to the President or the Vice President for Administration and Business Affairs to execute contracts for the construction, equipping and furnishing of the student apartment complex within the amount of funds available, defined as "the sum of bond proceeds and up to \$350,000 from (Housing and Food Services) reserve funds." The low bid for construction of the facilities was \$1,320,180 from Serenus Johnson and Son Construction Company of Bay City. Low bid on the bond sale was at 9.4 percent Still to be obtained are bids interest. for apartment furnishings, site preparation, landscaping, and installation of utilities.

President Ryder presented a resolution authorizing funding of 25 to 30 percent of the Children's Center budget from the general fund. The remaining 70 to 75 percent would be self generated from fees and other sources. He spoke of the needs filled by the Center, both in terms of child care that is provided and as an educational laboratory for SVSC students. Board member Curtiss inquired about the cost of liability insurance for the Center, noting that insurance costs for schools and child care centers had risen sharply recently as a result of litigation. He asked if the college was doing all that could be done to minimize institutional liability. Ted Braun agreed that a report should be presented outlining facts related to insurance coverage. The funding resolution passed by a 7-1 vote.

The Board approved promotions for seven faculty members. Moving from instructor to assistant professor rank were Ms. Sachiko Claus, nursing; and Ms. Jill Wetmore, marketing. Dr. Abbas Ali was promoted from assistant to associate professor of manage-

ment. Achieving the rank of full professor were Dr. Kay Harley, English; Dr. Albert Plaush, chemistry; Dr. Janet Robinson, psychology; and Dr. Harriet Tillock, sociology.

In addition, the Board approved granting of tenure to Ms. Sally Decker, assistant professor of nursing; Ms. Faith Edwards, assistant professor of nursing; Dr. Louis Jacoby, assistant professor of accounting; Dr. Michael Sovansky, associate professor of business law; Dr. Elaine Stephens, associate professor of education; and Dr. James Syphers, associate professor of social work.

In other action, the Board:

--commended Mrs. Dorothy R. Horwath for her accomplishments and dedication as interim director of the Library Learning Resources Center. The resolution noted her leadership in the development and implementation of the Valley Library Consortium, the automation of SVSC's library, the library approval plan, and the acquisition of library audio-visual equipment, as well as her assistance in planning for the new library facility and in the appointment of a new director of the Library and Learning Resources Center.

--approved a continuation of the general fund operating budget until the adoption of the operating budget for the 1985/86 fiscal year.

--adopted a meeting calendar that includes an October 14 meeting in St. Charles and special meetings on October 19 and 20 to receive input from various college constituencies on the long range planning process.

--heard a report on fall admissions. Executive Director for Admissions and Student Services Richard P. Thompson noted that admissions were down slightly from the same period in 1984, but said he believed projected enrollment levels would be realized before the beginning of fall semester.

--received a personnel report listing two administrative and nine faculty positions filled.
