SECRETARIAL/CLERICAL CONTRACT SETTLED

Although it took assistance from a state mediator, the SVSC Secretarial and Clerical Association (MEA) and the College have agreed on a new three-year contract extend-June 30, 1988. ing through Tentative settlement was announced last Wednesday negotiating teams met with after mediator Bill Borushko in a session that resolved differences standing in the way of agreement.

Wednesday's table Following agreement, secretarial/clerical employees returned to their jobs Thursday, ending a two-day The strike was the first in walkout. SVSC's history.

In announcing the table agreement, Vice President for Administration and Business Affairs Jerry A. Woodcock said, "We are pleased that contract issues have been resolved and that employees will be back on the job. The secretarial/clerical personnel are an important part of the SVSC family." Woodcock said the well-being of students was of prime concern to all parties. "We now can get on with the business of educating students. That is why we exist."

The agreement, which was ratified by Association membership Friday, and on approved at a special meeting of the Board of Control yesterday, included increases of 6.1 percent the first year, 5.25 percent the second year, and 3 percent on July 1, 1987, with another 3 percent increase on December 1, 1987. In addition, all secretarial/clerical employees not on the maximum step of their classification level will receive step increases that average 2.5 percent annually.

The last pact covering the secretarial/clerical workers was a two-year contract that expired June 30. Negotiations between the College and the Association began May 15. Additional meetings were held May 23 and 30, June 23, 25 and 27, and July 23 and 25. An impasse was declared at the July 25 meeting, and both sides agreed to call in a mediator. The teams met with mediator Bill Borushko August 8. The next agreed-upon meeting was September 4, but an additional meeting was scheduled, at the Association's request, when the mediator became available Thursday, August 29.

Chief negotiator for the College was Larry Fitzpatrick, director of personnel and contract administrator.
