CREF UNIT STATUS UPDATE

Participants with CREF units under the TIAA/CREF retirement plan recently received the fourth quarter statement for 1988, which reviewed the history of the CREF performance, It indicated the CREF units employees possessed Dec. 31, 1986, valued at \$31.27, decreased. On Dec. 31, 1987, the unit was valued at \$29.75. CREF's net rate of total return for 1987 was 5.3 percent. As of the close of the business day on Jan. 29, CREF's unit value increased 4 percent to \$32.52.

An understanding of the positive performance of CREF prior to the stock market "crash" in October, is helpful, according to Ann Schulte, assistant director of personnel. During the period Sept. 1, 1982 to Sept. 1987, CREF's value increased 242 percent. In monetary terms: each \$1,000 accumulated in CREF at the beginning of the period was worth approximately \$3,390. At the end of 1987, that same accumulation was valued at \$2,659.

For younger staff members with CREF units, short-term gains or losses are evaluated in a longer-term contract. When comparing CREF's longterm performance, Schulte said CREF has out-performed the Standard & Poor's 500 Index. She recommended referring to the Jan. 15 TIAA communication for a display of the Investment Return. TIAA states that for the 10 years, ending Dec. 31, 1987, inflation averaged approximately 6.4 percent, compared to CREF's average return of 15.7 percent.

Staff members with a fixed-dollar investment to offset the volatility of equity investments are earning a guaranteed return of 8.5 percent through Feb. 29, for current premiums, and at rates 9 percent to 11.5 percent on accumulations resulting from past contributions.

Illustrations of annuity income will be forwarded to each participant directly from TIAA around mid-March in the form of an annual report. Anyone that wishes to discuss those illustrations may contact the Personnel Office at extension 4108 or 4112.

NEW INFORMATION ON SRAS

An article titled "Ruling Issued on Salary Reduction Agreement: GCM Revoked," published in the January issue of NACUBO <u>Business</u> <u>Officer</u>, addressed the issue of SRA contracts.

The article reports the IRS has now determined a "once-a-year rule should be interpreted to allow one alteration in the SRA contract per year (by the employee), rather than one opportunity to change."

For SVSU employees, this means those who entered into a new contract for 1988, or those that extended their 1987 contract into 1988, are able to make one further alteration during the 1988 calendar year.

WINTER ENROLLMENT UP

Continuing a long-term trend, 1988 winter semester enroll-ment increased above the 1987 winter semester. Since SVSU began in 1964, each year, the winter semester has exhibited an increase over the previous year.

The 1987 winter enrollment was 5,020. This year, enrollment is up 7.5 percent to 5,395.

Credit hours are up 6.2 percent from 47,220 in 1987 to 50,152 in 1988.

The number of students living in apartments has risen 24.4 percent, from 90 residents in winter 1987 to 112 in winter 1988. The number of students living in residence halls increased from 460 to 466 in 1988, an increase of 1.3 percent.

The majority of students enrolled at SVSU are from Saginaw County: 2,079, a 6 percent increase over 1987's figure of 1,962.

NOMINEES SOUGHT FOR FIRST FOUNDATION AWARDS

In an effort to recognize outstanding achievement in service to SVSU, nominees are being sought for two Awards for Excellence in Service. Spring 1988 will be the first year such awards will be bestowed. One each will be awarded to a member of the faculty and to other SVSU employees.

The awards, which will include cash awards (of \$500 per award), appropriate plaques and public recognition, are funded by the SVSU Foundation.

The selection committee includes an academic administrator, and representatives from the Personnel Office, Board of Control, Board of Directors of the SVSU Foundation and a student -- all appointed by the president. After the initial award, the past year's recipients will become members of the committee.

Criteria to be considered for the recipients are participation in University activities, demonstrated interest in University community issues and concerns, contributions to the betterment of the University and participation and leadership on University committees or councils which are recognized as contributing to the education and/or social welfare of the University.

Other qualities sought are a willingness to accept responsibility for participation and leadership in community activities in such a way the University benefits, and service in the best interest of the University through effective performance in an assigned role.

Nominations may be sent via

memorandum to the committee chairman Larry Fitzpatrick, director of Personnel. Nominations should include a brief statement explaining how the nominee meets the established criteria.

In addition to Fitzpatrick, other members of the SVSU Foundation Award for Excellence in Service committee are Dr. Robert Braddock, academic administrator; Mrs. Jo Saltzman, chairman of the Board of Control; Mr. Melvin J. Zahnow, member of the SVSU Foundation; Ms. Lisa Tucker, president of Student Government; and Mr. Brian Law, member of the Board of Fellows.

-- Dr. Albert Menard, assistant professor of physics, delivered a paper, "Project SOLVE 1987: Teacher Preparation in Science and Gifted Education," to the national meeting of the American Association of Physics Teachers in Washington, D.C. Dr. Walter Rathkamp, professor of biology, director of Project SOLVE (Science Outreach Leadership Venture for Excellence), was co-author of the paper.

HIGH FIVE

- -- Senior Sabrina Arnold set an SVSU **track** record at the MSU relays with her 7.13 time in the 55-meter dash. Arnold finished third for the Lady Cardinals and snapped the mark of 7.39 established by Felipa Smith in 1986.
- -- SVSU's men's distance medley relay team of freshman Jeff Boks, junior Chris Ludka, and seniors Brad Abendroth and Shaun Butler, qualified for the NAIA national indoor track meet with a 10:12.40 clocking at

MSU. The squad finished fifth.

- -- Phillip Miller became the 11th SVSU men's basketball player in history to reach the 1,000-point plateau. Miller scored 43 points in two games last week, pushing his career total to 1,008. The 6-6 senior captain also moved into seventh in career steals with 116, passing Larry King (1984-86) and A1 MacDonald (1978-81). Miller led SVSU in scoring with 23 points Saturday, the first time he has led the Cards since Dec. 17.
- -- SVSU women's basketball team, ranked 19th in the NAIA last week, now has won eight straight games. The Lady Cardinals beat Aquinas and Hillsdale last week to push their NAIA District 23 win streak to 47 games. Sophomore center Brenda Eiseler had a career-high 24 points in SVSU's victory over Aquinas College Tuesday.
- -- SVSU senior women's basketball captain Sue Mayes-Scott passed current student assistant coach Sonja Paquin (1983-86) for second on the all-time steals list with 315. Junior Trena Sanders passed Sherry Reder for ninth on the alltime scoring list and has 966 points. A 5-11 forward, Sanders moved into eighth past Erika Bush (178-81) and Sandy Theriault (1984-87) on the all-time steals list with 191.

BOARD REPORT



A Report of the Saginaw Valley State College Board of Control

February 9, 1988

In his remarks preliminary to the action portion of the Board agenda, President Jack M. Ryder told members he had made phone contact with Don Powers to discuss a proposed faculty/administration retreat, but the project will not be initiated in the near future.

Ryder said the decision not to move forward came because of concerns expressed by Faculty Association leaders. Powers told Ryder he felt the Association was reluctant to enter into the retreat at this time, and the project would not be productive without support from both faculty and administration.

The executive board of SVSU/FA met with Ryder, Vice President Yien and Vice President Woodcock on Thursday, Feb. 4. The meeting, Ryder said, verified Powers' assessment of the faculty leadership's feelings toward a retreat. "The basic issue was the last (contract) negotiations." Professor John Willertz concurred.

Several Board members urged that faculty and administration make substantive progress toward establishing meetings to identify and resolve problems. They said the specifics of the process were open to change and need not involve Powers or his organization. However, in view of the NCA focus visit

set for the 1988/89 academic year, the two groups should move forward. They asked for agreement on an acceptable third party (for conducting the joint retreat or seminar) by the next Board meeting.

Ryder presented an update on the Governor's budget recommendation for higher education. In conjunction with his "State of the State" address, Gov. Blanchard called for a 1 percent increase for higher education. That was based on the current year base after it was reduced by .75 percent, and one-time-only enrollment recognition funds were subtracted. Therefore, the amount recommended for SVSU in fiscal year '89 actually is \$21,000 lower than the original appropriation for fiscal year '88.

Since the original recommendation, the Governor has revised his budget downward. If this later figure holds, SVSU would face a 2.4 percent reduction in next year's appropriation. Ryder reminded the Board that the appropriations process has just begun, so there is hope for improvement. However, he anticipates a difficult year ahead. Senate budget hearings begin in March.

Board members approved a "Student Rights and Responsibilities" document presented by Student Government leaders. Work on the statement began four years ago and

has involved students, faculty and administration. It covers such issues as academic evaluation. academic freedom, advising, student records, participation in institutional governance, student publications, freedom of association, and affirmative action. Faculty have approved sections that directly apply to them, according to Association President Willertz. Board member Charles Curtiss congratulated the committee on its work, but urged addition of a "Student Responsibility" statement to the section on publications.

1988 salary adjustments for the University's top administrators were approved. The president and two vice presidents each received 6 percent increases. Under the new pay scale, Vice President Yien will receive \$70,320 annually. Vice President Woodcock's new salary is \$75,843. Dr. Ryder will be paid \$79,860 in current salary and \$6,000 in deferred salary. His 1987 salary base included \$75,000 current salary and \$6,000 deferred compensation. Board chairman Jo Saltzman commended the administrators on their leadership abilities and said the Board looked forward to "another excellent year."

Representatives from the College of Education continued their report of

activities, begun at an earlier meeting. Dean David Nelson told the Board that the College has initiated use of a standard exam prepared and scored by Educational Testing Service for students seeking admission to teaching programs. Secondly, he said, the revisions in the elementary education degree plan have been submitted to and approved by the University's curriculum committee, and will go to the faculty for ratification in March. Next, the College will review the status of its graduate programs.

Dr. Jose Valderas, director of bilingual/bicultural education, reported on bilingual teacher training programs. He presented documents showing the selection criteria for students entering the program, a winter schedule of student activities, and a data sheet showing the grade level, ethnic background, geographic location and fall grade information of the 54 students currently enrolled. The data show 47 undergraduates and seven Bilingual Endorsement candidates. Of these, 44 are Hispanics, nine Caucasian and one Black. The majority (33) are from Saginaw, with nine other cities represented. Of the 58 students enrolled fall 1987, 45 received a GPA of 3.0 or better. A support service plan is in place to assist any students who fall below the required 2.75 GPA.

Valderas' presentation included an external evaluation that rated the program as achieving "beyond expectations" in four areas and as "totally achieving" objectives in seven other areas. One final objective was listed as "partially achieved." Nelson noted the program has received national acclaim.

Dr. Douglas Hansen, professor of physical education, updated Board members on developments in his department. He said the progress on construction of the health and physical education complex is on schedule. "Now we are looking at what we need in staffing and resources to start up the building."

Hansen said he anticipates dramatic growth in the number of students majoring in phys. ed. once the facility is available. The current enrollment of 90 could swell to 200 in the next three years, he said. Also, some areas, such as human performance, will have significant new capabilities, and others, such as aquatics, will be new programs. He reported that about half of the current phys. ed. students become teachers, while the remaining move into the business area.

Anticipated curriculum revisions include more lab experiences for all phys. ed. majors, expansion of offerings in fitness and rehabilitation and possibly adding a phys. ed. requirement for all SVSU students. Also, a separate major might be added for students interested in fitness and management.

In other action, the Board:

- -- ratified the change from "school" to "college" for designation of academic units.
- -- approved emeritus status on the Board of Fellows for Ellis Ivey.
- -- received a proposal for granting emeritus status to Board of Control members and establishing privileges and responsibilities attendant with that status.
- -- heard an enrollment report

for winter semester showing a 7.5 percent increase.

-- received a housing report showing apartments filled to capacity and dormitory occupancy up from last year.

Discussion items at the Business and Facilities Committee meeting included:

- -- Update on the line of credit: Michigan National Bank has indicated its legal counsel questions SVSU's authority to borrow funds. The issue is being explored and a relationship will be sought with another financial institution if necessary. SVSU has maintained the line of credit since 1982.
- -- Discussion of forward funding language: the current appropriations bill does not have a sunset date and Woodcock believes the procedure will be on-going.
- --Status of the 1987-88 operating budget: the balanced budget presented in August now shows a deficit of \$82,000. However, \$89,000 in unallocated resources can be used to cover this. The executive order reduction of \$103,000 will be recognized in the 1988-89 budget year.
- -- Reconciliation of the 1986-87 budget with actual revenues and expenditures: total revenues were greater than in the approved budget and expenditures less, increasing the balance at the year's end to \$246,643.
- -- Room and board rates: fees usually are set in April so students can plan for fall. A 4 to 6 percent increase is anticipated. SVSU has had the second lowest increase of Michigan's public universities during the past seven years.
