Faculty, Staff Orientation Set

New faculty and staff will have an opportunity to become acquainted with offices and personnel on campus during the 1989 Faculty/Staff Orientation Aug. 23 and 24.

Orientation for new faculty and staff will take place from 1:30 to 4 p.m., Aug. 23 in Lower Level Doan Center. The orientation will include tours of various offices on campus. In addition, all faculty and staff members will have the opportunity to greet incoming-President Eric R. Gilbertson on Aug. 31.

On Aug. 24, department chairpersons will meet from 10:30 to 11:30 a.m. in the Large Private Dining Room of Doan Center. Following a short break, lunch will be served for faculty from 11:45 a.m. to 1:30 p.m. The luncheon will feature Dr. George M. Dennison, provost and vice president for academic affairs at Western Michigan University.

The five colleges then will break into groups and meet with their respective deans from 1:45 to 3:15 p.m.:

Arts and Behavioral Sciences, Dean William K. Barnett, Room 127, Brown Hall.

Business and Management, Dean James L. Mitchell, Room 207, Brown Hall.

Education, Dean David E. Nelson, Room 214, Brown Hall.

Nursing and Allied Health Sciences, Dean Crystal M. Lange, Room 246, Wickes Hall.

Science, Engineering and Technology, Dean Thomas E. Kullgren, Room 158, Pioneer Hall.

Committee meetings will follow the college meetings from 3:30 to 4:30 p.m. in various conference rooms on the third floor of Wickes Hall.

Dr. Robert S.P. Yien, vice president for academic affairs, will introduce new faculty and recognize faculty promotions during a faculty/staff meeting on Aug. 31 in Wickes Lecture Hall. Following Yien's introduction, President Gilbertson will make address the campus community. A reception will follow in the lobby of the Arbury Fine Arts Center.

Freshmen Admissions Closed

Admissions for freshmen and first-time-incollege students at SVSU were closed Aug. 4. Transfer students, however, may enroll during open registration periods on Aug. 16 and 17 and 21 and 22.

Jim Dwyer, director of Admissions, said 1,757 students have been admitted for fall semester -- up 4.5 percent from 1988. In all, 2,364 students applied for admission -- up from 2,208 in 1988, a 9.4 percent increase.

According to Registrar Paul Saft, many freshmen composition and other entry level courses are at capacity. Many of the upper division (junior and senior) level classes still have vacancies, Saft continued.

For the past two years, SVSU has limited the number of new students enrolled to approximately 1,700. The policy was adopted to keep enrollments in line with funding, according to Vice President for Academic Affairs Robert S.P. Yien.

"Until we have sufficient revenue to hire additional faculty, we have decided to contain our enrollment to the number of students we can adequately serve," Yien said.

In 1988, 2,208 students applied for admission; 1.728 were admitted. Thus far in 1989, 2,364 have applied and 1.757 have been admitted. This represents an 9.4 percent increase in applications and a 4.5 percent increase in admissions.

SVSU Drops NAIA Affiliation; Joins New Football Conference

Two long-time friends have parted ways. SVSU has elected not to renew its membership in the National Association of Intercollegiate Athletics (NAIA) for the 1989-90 school year. In addition, members of the Great Lakes Intercollegiate Athletic Conference, including SVSU, and the Heartland Collegiate Conference have merged to create the Midwest Intercollegiate Football Conference, beginning with the 1990 season.

Athletic Director Robert Becker informed the NAIA executive director of SVSU's decision to drop its NAIA affiliation in order to participate in NCAA Division II postseason play for all team sports. The decision followed a May meeting of the GLIAC executive council. The league hopes the move will enhance efforts to secure automatic berths to NCAA postseason play for its league champions.

SVSU has been dual-affiliated (NAIA and NCAA II) since the GLIAC passed

legislation in 1982 requiring all league schools to hold NCAA affiliations.

"The NAIA has been good to SVSU and we have enjoyed a long and pleasant relationship," Becker wrote. "I believe, however, this move will be beneficial to the GLIAC and SVSU in the long run. I look forward to striving for success at the NCAA Division II level."

SVSU has enjoyed great success in NAIA postseason competition, sending no fewer than seven teams to NAIA nationals in each of the last eight years. The Cardinals have won three NAIA national championships: men's indoor track in 1982 and 1983; and softball in 1989. SVSU won the NAIA men's all-sports trophy in 1982 and 1984, with the women's program finishing runner-up in 1982.

The merger of the GLIAC and HCC came in March, when formal commitments were submitted by all 11 schools of the two conferences. The group approved and adopted a constitution and schedule to begin Sept. 1, 1990. The merger affects football play only.

BOARD SETS BUDGET, RATI-FIES PRESIDENT'S CONTACT

Adoption of the general fund operating budget for 1989-90 and approval of a contract for incoming President Eric R. Gilbertson occupied the number one and two spots on the SVSU Board of Control agenda Monday. Both items garnered unanimous support from Board members.

The budget, based upon an appropriations bill recommended by the Legislature's Conference Committee but as yet unsigned by Gov. Blanchard, calls for general fund expenditures of \$24,559,000 in the 1989-90 fiscal year.

Although it was presented as a balanced budget, Vice President for Administration and Business Affairs Jerry A. Woodcock explained that a projected \$100,000 surplus to be carried forward from the current year may be eliminated by the writing off of some \$50,000 relating to the acquisition of DEC computers plus an unspecified amount in accounts receivable for athletic awards. Woodcock indicated there could be a deficit of approximately \$25,000 rather than a surplus to carry into the '89-90 fiscal year. In that eventuality, Board members would later be asked to approve revisions to the budget adopted today.

Woodcock expressed appreciation for higher than expected State appropriations. The total increase of 8.9 percent over '88-89 allocations includes an increase of 6.74 percent in general operations funds, plus an added 2.15 percent in start-up money for the

Ryder Health and Physical Education Center. The building start-up funding of \$304,000 is approximately half the amount state officials agree is necessary for facility operation, Woodcock said.

The new budget provides for expenditures that enhance educational quality, Woodcock said, citing the addition of five full-time faculty and the restoration of funding previously cut from library expenditures. Also, the SafeHaven program will be operated through general revenues as the grant that established it is phased out.

A one year employment agreement between the University and Dr. Eric R. Gilbertson sets the new president's salary at \$95,000. President Gilbertson's appointment is effective August 28. According to the terms of the agreement, the president's performance will be evaluated by the Board, a Board committee, or through another mechanism specified by the Board. If such evaluation is positive, the contract may, at the option of the Board and President Gilbertson, be extended for three additional years under mutually agreed upon terms.

In addition to his salary, Gilbertson will receive use of an automobile and will reside in the presidential residence owned by the University. Gilbertson also will receive such fringe benefits as health and life insurance, vacation and sick leave and retirement benefits similar to those available to the administrative/professional staff generally.

Dr. Crystal M. Lange reported on

proposals for a Business Innovation and Professional Development Center being sought for the campus. Lange chaired a committee that developed the program statement for the facility last year.

Among the purposes of the center is to provide resources, programs and an environment for the development of human skills and services necessary for economic growth in the East Central Michigan area. The 138,000 square foot center would encompass facilities for three separate but related purposes: instructional, conference and student activities. The proposal calls for classroom and office space for the College of Business and Management; a variety of conference and meeting rooms; office space for the Conference Bureau, the Business and Industrial Development Institute and the Chrysallis Center; food service and dining facilities and a student union and bookstore.

Another feature is a "21st century" telecommunications center that would link a consortium of institutions serving the region. The network would provide instructional capability to support the Regional Math/Science Center and the Regional Teacher Professional Development Center, as well as other educational initiatives.

Cost of the new facility is projected at \$16.5 million, with \$8.25 million in self-liquidating projects such as the bookstore, Lange said.

Also moving through the planning and approval process is a centralized heating and cooling plant pegged at \$28.1 million. The central plant would replace individual boilers and

cooling units currently serving campus buildings. Dr. John Fallon, assistant to the president and secretary to the Board of Control, said SVSU may have to choose which of the two projects should take priority. Planners estimate the heating and cooling plant could result in savings of \$350,000 to \$500,000 annually, achieved through more efficient operation, as well as reduced labor and repair/replacement costs.

Near the end of the meeting, Student Government President Roger Powell addressed Board members regarding an alleged sexual harassment incident that occurred in May. A formal complaint was filed by a student against an instructor, and Powell sought information on the disposition of the case. He said the student had been informed at one point that the case was closed, but recently learned that other members of the class were being interviewed relative to the matter.

Board Chairman Florence "Jo" Saltzman reminded Powell that the Board was a policy-making body and that there were administrative procedures in place to deal with such incidents. She instructed administrators to review the situation and bring back a recommendation to the Board.

In other action, Board members:

- --learned that summer enrollment was down 98 students, a 3.1 percent drop, from last summer. The 3,024 students signed up for 16,171 credit hours, off 5 percent from the summer 1988 total of 17,030. The drop was in part attributed to an unusually high influx of students last summer, many of whom opted to enter before new General Education requirements took effect fall semester.
- -- received a report comparing fall semester enrollments to date with the corresponding period last August. With four days of regular registration remaining plus four days of late registration, fall 1989 headcount stands at 4,815, up 2.2 percent from fall 1988. The count for credit hours is also 1.6 percent above a comparable date last year, at 49,514.
- -- were informed that both residence halls and the Pine Grove apartments are filled to capacity, as has been the case for several years. Some students on the waiting list for housing will be referred to Delta College dorms; others will commute, and some will not be attending SVSU unless suitable housing can be arranged, according to Residential Housing Director Merry Jo Starrine.

- -- met six students from Shikoku Women's University in Tokushima, Japan. Four will be spending three weeks on the SVSU campus, while two will remain for 10 months.
- -- met Raquel Ontiveros, 1989-90 KCP visiting professor.
- -- were informed that Michael Panhorst has been selected as curator of the Marshall M. Fredericks Gallery. He will begin his duties October 2.
- -- received a personnel report listing 11 new faculty and several administrative/professional changes. See "Transitions" for details.
- -- adopted resolutions formally naming the Ryder Health and Physical Education Center and the James E. O'Neill Jr. Arena.
- -- approved an amendment to the travel policy increasing reimbursement from \$.20 to \$.24 per mile and eliminating the reimbursement rate structure based upon availability of a Motor Pool vehicle. (Those who choose to drive their personal cars are eligible for the \$.24 rate.)


