SVSU in Line for New Central Heating and Cooling Plant

SVSU was among three state universities and nine community colleges whose plans for major new construction projects were given preliminary approval in Lansing last week.

The Joint Capital Outlay Subcommittee, chaired by State Representative James E. O'Neill Jr. (D-Saginaw), approved a fiscal 1993 draft budget bill which, if approved by the full House and Senate and signed by the Governor, will enable construction of a \$33 million central heating and cooling plant on the SVSU campus.

Appropriations earmarked for SVSU are part of a \$176 million package that included Michigan State and Western Michigan Universities. SVSU's centralized plant would replace 64 individual heating and cooling units that now provide service to buildings around the campus. Community colleges included in the measure will match state appropriations

with local funds to complete their projects.

"The new facility could save the University as much as \$500,000 a year," according to John Fallon, vice president for public affairs. "It would cut the cost of gas and electricity, as well as the cost of equipment replacements, for which we now spend about \$125,000 a year.

"The new heating and cooling equipment has a useful life expectancy of about 25 years and will require fewer operating and maintenance personnel," Fallon said.

A centralized plant originally was proposed for the University in 1977 when a technical and economic feasibility study validated its need. Feasibility of the project was revalidated in 1989 and 1990 by two separate design firms.

Fallon said the University is "grateful and very pleased by the action of the subcommittee." Appropriations from the bill will pay for completion of drawings and construction of the plant, Fallon said.

High Grades Help 45 SVSU Students Cut Education Costs

Three SVSU students who maintained high grade point averages and demonstrated leadership in campus activities will see their education costs cut next fall.

Michelle Frost, Tamara Harris and Mark Zelley will receive a combination of awards and scholarships that will lower their tuition and fees by \$300 a semester.

Frost, Harris and Zelley are among 45 students whose high GPAs made them eligible for awards covering tuition and fees. By maintaining at least a 3.40 GPA throughout their college careers, 23 students were selected as first time winners of Recognition

Scholarships, which will reduce their tuition and fees by \$200 a semester. Recognition Scholarships for another 16 students were renewed.

Six students who maintained a 3.25 GPA or better and demonstrated leadership in University activities and programs will receive Achievement Awards that cut tuition and fees by \$100 a semester.

Frost, Harris and Zelley were first time winners who received both Recognition Scholarships and Achievement Awards from a committee that evaluated all applications from students of sophomore standing.

Academic High Achievers Choose SVSU

Three area high school seniors who were featured in a recent newspaper advertisement are among 36 students who will use Presidential Scholarships and Awards for Excellence to begin full-time studies next fall at SVSU. The three, who were featured in the May 26 Saginaw News special section titled "Valedictorians and Salutatorians," are among 16 incoming freshmen who maintained a 4.00 grade point average in high school.

Though Steven T. Haske, Rebecca N. Jerome and Kari N. Richter were highlighted in the SVSU advertisement, they represent only part of this year's graduating class of high academic achievers who were awarded scholarships covering tuition, fees and books while they work toward baccalaureate degrees. The scholarships are annually renewable for students who maintain at least a 3.60 GPA.

Haske is undecided about his major, but was a strong three-year performer on the Reese High School Science Team and won silver and bronze medals in the Regional Math Olympiad. He also was a three-year participant in the Science Academic Games. Haske, who was class Valedictorian, is described by one of his science teachers as being "ready to meet any academic challenge."

Jerome also is undecided about her major. While attending Arthur Hill High School, she showed interest in a number of subjects and was a member of the Science Club and Modern Foreign Language Club, and was named an outstanding student in science and social studies. As a senior she was a national merit scholar finalist. One of her teachers said she was impressed by Jerome's "quiet competence and consistent preparedness in her daily assignments." Though Jerome ranked first in her graduating class, Arthur Hill does not designate a Valedictorian.

Richter plans to major in nursing. She was a member of the Freeland High School marching and symphonic bands and was president of both the band and the National Honor Society during her senior year. She was cocaptain of the cheerleading squad and placed second in the DAR essay contest in 1988, and was among the top ten finalists in the Con-

gressional Page competition in 1990. She scored 100 percent in the English and mathematics sections of the MEAP test. One of her teachers said "she takes her education seriously and likes to challenge herself by taking advanced classes." Richter was class Valedictorian.

FY '93 Budget, Land Proposal To CIESIN Topped Control Board Agenda

With student enrollments up five percent over a year ago, credit hour growth up three percent and no increase expected in the fiscal '92 level of state appropriations for higher education, the University Board of Control approved a fiscal '93 budget of \$30.68 million, which included a fall tuition increase of 8.42 percent. The Board also approved a \$1.50 winter semester increase in general service fees.

Anticipating at least a three percent rise in enrollments, the Board endorsed the addition of six full-time faculty positions, one each in English, psychology, criminal justice and science education, with one year instructorships in mathematics and biology. Added tuition of \$1.15 million and \$340,000 in additional credit hour revenues are expected to offset a 5.58 percent increase in operating costs including an additional \$25,000 increase in adjunct faculty rates, \$25,000 for library acquisitions and a 3.65 percent increase in the cost of supplies and materials.

Though state government is seeking to reduce its budget deficit, President Gilbertson said "there is evidence of strong support by the governor and the legislature because they are not cutting state aid to higher education." He noted that many other states have reduced appropriations to universities and colleges. During the past 17 years, Michigan's contributions have declined from 72 to 58 percent of college and university general fund budgets while tuition and fees have risen from 27 to 39 percent.

During its June 8 meeting, the Board proposed dedication of 160 acres of University property for the benefit and use of the Consortium for International Earth Science Information Network (CIESIN). Meeting in Executive session, the Board approved a proposal for construction of a permanent scientific facility and related developments on the campus.

The site proposed for CIESIN's permanent headquarters was the northwest quadrant of SVSU's campus adjoining the intersection of Bay and Freeland Roads that would be divided into three parcels. An 80acre perimeter parcel would be maintained as a "greenspace" or "ecology zone" for the benefit of CIESIN. Within this perimeter, a 40-acre parcel would be deeded to CIESIN for construction of its Global Change Data and Research Headquarters. A second 40-acre parcel within the perimeter would be controlled jointly by CIESIN and SVSU and would be available for future CIESIN expansion. The parcel would be subject to use restrictions, that the property be used for scientific research and educational purposes, and would revert to the University in the event CIESIN ceased using the land for a headquarters and principle place of business.

The Board's decision was based on the assumption SVSU would benefit not only from CIESIN's research and related work taking place on the campus but also that University faculty and students could become involved in CIESIN's work. The Board approved an alternative proposal that offers CIESIN title to a full 80 acres at the northern end of the campus. No time limit was set for CIESIN to consider the proposals.

This is an unofficial report of Board activities. Official minutes are on file in the library.

President Gilbertson subsequently circulated a letter, dated June 9, to all University staff and faculty members explaining the Board's decision on both issues.

During its regular meeting, the Board was also advised that eight administrative/professional positions have been filled. They include Ms. Barbara A. Anderson Eddy, director of scientific outreach, Institute for Environmental Policy and Education; Ms. Cynthia I. Bala, promoted to grant accountant, Office of the Controller; Ms. Lori A. Schwietzer, buyer, Office of Business and Auxiliary Services.
