## **Engineering programs benefit from three endowments**

**T**he continued generosity of a Midland foundation will enable Saginaw Valley State University to enhance its engineering area through the establishment of three endowments: a fund to provide support for an endowed chair in engineering, a student scholarship endowment fund and an engineering equipment endowment fund. The Charles J. Strosacker Foundation, through the Campaign for Distinction, modified a previously created endowment and provided additional funds toward the establishment of the chair and the scholarship fund.

Eugene C. Yehle, chairman of The Charles J. Strosacker Foundation, said the organization initially invested in the University "toward hopes it would grow to be the institution it is today."

"Certainly today I think of Saginaw Valley as an outstanding institution and a great credit to our area," Yehle said. "It is a credit to our area and fulfills a tremendous role, not just in our area but the state.

"We want to ensure it continues that role into the future."

**The Charles J. Strosacker Endowed Chair in Engineering** was established to recognize Strosacker, a distinguished business and community leader. The endowed chair will be a full-time administrative/professional position occupied by a scholar and teacher in SVSU's College of Science, Engineering and Technology. Total funding for the Chair endowment from all sources will be \$1.25 million.

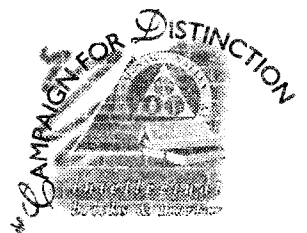
The work assigned to this position will include regular teaching assignments at the graduate and undergraduate levels, and scholarly work and service in support of SVSU's research and service missions.

**The Charles J. Strosacker Scholarship Fund** will provide scholarship assistance for

students who demonstrate an interest or aptitude in engineering or science, with the emphasis on disadvantaged and/or under-represented students pursuing a degree in engineering, science, science education or mathematics. The fund was made possible by a gift of \$100,000 from the Strosacker Foundation.

The establishment of the scholarship fund is an evolutionary step from Project GET-SET, which was established at SVSU in 1990 with support from the Strosacker Foundation. The aim of the GET-SET program had been to help and encourage disadvantaged students in middle or high school to seek careers in science and engineering. Approximately 500 students participated in the program during a five-year period. While the GET-SET program encouraged students to begin studies leading to technical careers, "graduates" from the program often lack the financial resources to attend college. The Charles J. Strosacker Scholarship Fund will provide scholarship support, which can be the margin of difference for high-potential, but at-risk students.

**The Charles J. Strosacker Engineering Equipment Endowment Fund** is established to provide resources for the acquisition of new equipment and the upgrading of existing equipment necessary for achieving academic excellence in SVSU engineering programs. A gift from the Strosacker Foundation in 1981 was used to create a term endowment to help maintain Pioneer Hall and insure its continued aesthetic and functional properties. With the concurrence of the Strosacker Foundation, the term endowment was dissolved in 1998 with the corpus of the fund distributed between the equipment endowment and the endowed chair in engineering.

Distributions from the endowment are to be used for the purchase of new engineering equipment and related supplies, the renovation and upgrade of existing equipment, minor building modifications as required to support the purchase or renovation of engineering equipment, and those maintenance services deemed necessary for the reliable operation and preservation of equipment acquired from endowment resources.

The equipment endowment has been established with a corpus of \$650,000.

Yehle added that Martha Arnold, a trustee with The Charles J. Strosacker Foundation, also is an honorary member of the SVSU Foundation. Arnold is a past chairperson of the SVSU Foundation. She also established a scholarship fund at SVSU in memory of her husband, James B. Arnold: The James B. Arnold Engineering Scholarship. Mr. Arnold was a former president of The Charles J. Strosacker Foundation.

Both Martha and James Arnold received SVSU honorary degrees: Mrs. Arnold in 1984 and Mr. Arnold in 1975.

## Affinity Card to replace American Express Corporate Card

American Express has ended its Corporate Card relationship with the state of Michigan and, thus, with SVSU. However, for the nearly 130 individuals who had American Express Corporate Cards under the program and any others interested, SVSU has entered into an agreement with MBNA to provide an affinity card beginning in the fall.

Participants may dedicate the MBNA card to business travel, or use it for personal pur-

chases. Reimbursement processes will remain the same: Within five days of filing an expense report, the Controller's Office will reimburse the individual.

The MBNA card will provide a collision damage waiver for rental vehicles. Also, in many cases, an individual's own insurance company will provide similar coverage. Be sure to check with your insurance provider for the coverage option.

Those holding American Express cards are reminded the program expires June 30. Materials will be available this summer for the MBNA affinity card.

"I regret the short notice of this action and any resulting inconvenience. American Express for reasons unknown did not notify University officials on timely basis of their decision to not renew the Corporate Card contract," said James G. Muladore, controller and assistant vice president of administration and business affairs.

## Theta Chi inducts 17

Undergraduate students must have at least a 3.00 grade point average on a 4.00 scale and must be in the upper one-third of their nursing class to qualify for membership.

RN to B.S.N. students also must have at least a 3.00 grade point average on a 4.00 scale and must be in the upper one-third of their nursing class to qualify for membership.

Graduate students must have a 3.50 grade point average on a 4.00 scale and must be in the upper one-fourth of their nursing program.

## **Business Foundation Certificate offered for non-business grads**

SVSU's College of Business and Management will offer a Business Foundation Certificate program designed especially for the college graduate who did not major in business. By completing eight two-credit graduate courses in accounting, economics, finance, administration, marketing, operations management, statistical methods and the legal environment of business, the student will obtain a broad understanding of business.

The program will begin with the fall 1998 semester. The certificate program can be completed in one year. Courses are scheduled so students can complete two courses while attending class just one evening per week.

Admission to the certificate program does not guarantee admission to SVSU's Master of Business Administration degree program; however, if the student applies to and later is admitted to the MBA program, courses with a grade of B or better can be used to waive foundation courses.

Applicants must have a four-year bachelor's degree from a regionally-accredited college or university. Students must maintain a 3.0 grade point average (on a 4.0 scale). A minimum of 12 credits must be completed at SVSU.

Munger's appointment was effective June 10.

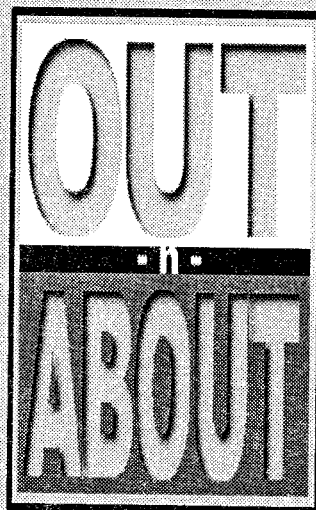

### **Math, science focus of camps**

SVSU's Regional Mathematics and Science Center will host fun and learning day camps during the month of July for kids entering grades 2 through 8 next fall.

Science and Mathematics Extravaganza for Kids Camps (SMEK) will offer three sessions with topics ranging from aeronautics and space to volcanoes and computers.

All-Star SMEK, Camp One, will be Monday, July 20 through Friday, July 24 from 8:30 a.m. to 3:15 p.m. each day for students entering grades 5 through 8 in the fall. The camp will have an aeronautics and space theme for the entire week. Cost of All-Star SMEK is \$150 per student.

SMEK Camp Two, for students entering grades 5 through 8 in the fall, will be a SMASH! (Science/Math Activities for a Summer Holiday) Monday, July 27 through Friday, July 31, 8:30 a.m. to 3:15 p.m. daily. Topics range from weather, volcanoes, rocks, minerals and fossils to measurement, small car construction, models of the solar system, star maps, constellations, model rockets and computers. Cost of SMASH is \$150 per student.

SMEK Jr. is for students entering grades 2 through 4 in the fall. It will be from 9 a.m. to 2:30 p.m. Wednesday, July 8 and Thursday, July 9. Students will participate in a potpourri of science projects centered around hands-on projects. Daily sessions at the Ryder Center pool will be included in the \$50 program fee.

Camp costs include all materials, snacks, lunches and Ryder Center fees.

If a student wishes to participate in both SMEK Camp One and SMEK Camp Two, the cost is \$275. Two students from the same family also may attend the same SMEK Camp for \$275. There is no discount on SMEK Jr.

# Board Report

A Report of the Saginaw Valley State University Board of Control

June 22, 1998

## Board approves FY98 budget, sets tuition rates

The SVSU Board of Control Monday, June 22 approved the 1998-99 General Fund Budget, which included a 2.3 percent increase in undergraduate tuition and fees.

The General Fund Budget is expected to include an increase in state appropriations (based on a Senate recommendation) of 3.58 percent, toward a total budget of \$1.523 million. The budget also shows a 3.82 decrease in expenditures of Supplies, Materials and Services, which reflects termination of the CIESIN rental agreement and budgeting of FY98 unallocated tuition revenue expense to Compensation for new faculty.

The proposed budget includes seven new full-time faculty positions and additional administrative/professional staffing. It also includes replacement of retired or departed faculty and administrative/professional staff members.

The operating budget includes a 2.5 percent inflationary increase in student financial aid, plus nearly \$170,000 for additional merit-based scholarships (Presidential Scholarship, Deans' Scholarship, University Scholar and Awards for Excellence). A graduate fellowship program also is proposed.

The budget also reflects a projected 2 percent increase in enrollment.

1998-99 tuition for Michigan undergraduates will be \$113.75 per credit hour. Graduate courses for Michigan residents will be \$167.20.

SVSU's 1997-98 tuition and fees ranked third lowest in Michigan. In 1996-97, SVSU was ranked fourth lowest. The proposed tuition increase remains below the 1997 CPI rate; thus, under current legislation, SVSU students would be eligible for a Michigan tax credit.

In other Board action:

- The Board approved several revisions to the Code of Student Conduct, including more clearly defining a stalking/harassment regulation, sexual assault, aiding and abetting violations and the addition of a suspension sanction within the Disciplinary Process article.

- Revisions also include modifications to the Counterfeiting, Altering, Fraudulent Use or Copying regulations to include via electronic means. The Disorderly Conduct regulation was expanded to include any University-sponsored function or academic requirement. The Assault regulation now includes reference to written and electronic transmissions.
- Ten new members were named to the SVSU Board of Fellows and four were reappointed to their positions. Newly-appointed were Leo Blanchard Jr., Steven K. Gaut and Renee Hampton all of Saginaw, Judy Z. Keller of Frankenmuth, John M. Kunitzer of Saginaw, Kenneth W. Lecureaux and Elyse M. Rogers of Midland, James L. VanSlembrouck of Saginaw, and David G. Wilkins of Midland. Reappointed were Robert D. Braem of Caro, John A. Decker of Saginaw, Paul M. Keep of Bay City and John W. Kendall of West Bloomfield.
  - The Board approved a resolution to add seventh and eighth grade classes to Creative Learning and NewLand academies for the fall.
  - The Board confirmed two new board members each for NewLand Academy and Chatfield School. All four are reappointments.
  - Two members of the Marshall M. Fredericks Sculpture Gallery board were reappointed and two more named by the Board of Control. Anne Thompson and Richard Strickland of Bloomfield Hills were reappointed to three-year terms. Suki Fredericks of Vermont and Don B. Gill of Bloomfield Hills were named to three-year terms.

Robert Yien, vice president for academic affairs, updated the Board on a recent working retreat with the deans and directors in his division.

Steve Hocquard, director of engineering services, updated the Board on construction activities.
