This roster includes the candidates (i.e., test takers) who took the Michigan Test for Teacher Certification between the dates indicated on the annual pass rate report, whose initial attempt for each test field occurred within that date range, and who both indicated affiliation with the institution during the registration process and were not deemed ineligible by the institution.

This report presents, for the designated institution, a roster of candidates who fit the criteria as described above and includes for each of these candidates:

- 1. (Column A) the institution with which the candidate is affiliated
- 2. (Column B) the candidate's last name
- 3. (Column C) the candidate's first name
- 4. (Column D) the last 4 digits of the candidate's Social Security Number
- 5. (Column E) the candidate's Evaluation Systems-assigned customer identification number
- 6. (Column F) the test code for the test field taken by the candidate within the timeframe as described above (note that if a candidate took more than one test within the designated timeframe, the results for each test field will be provided on a separate row of the roster)
- 7. (Column G) the date of the candidate's initial attempt on the test field
- 8. (Column H) the date of the candidate's latest attempt on the test field (within the timeframe of this roster)
- 9. (Column I) the candidate's pass/fail status on their initial attempt on the test field
- 10. (Column J) the candidate's pass/fail status on the best attempt (attempt with highest score, which may or may not be latest attempt) on the test field

## **Interpretive Notes/Cautions**

Educator preparation institution designations are based on self-reported information provided by candidates during the registration process. For candidates who tested more than once within the designated timeframe as described above, their affiliation is defined by their initial eligible attempt, if they designated an institution at the time of registration for their first attempt and were not deemed ineligible by that institution. If a candidate did not indicate

an attending institution during the registration process for their initial attempt, then their affiliation is defined by the institution they designated when registering for their latest eligible attempt.
