



SVSU License Plate Order Form

When you purchase an SVSU plate, SVSU is covering the \$35 cost to replace your plate. Your new plate will arrive by mail within 4-6 weeks. A \$10 fee is added to your vehicle registration fee when renewing a fundraising plate. The \$10 fee goes to SVSU in order to support the SVSU Legacy Program. Please note that SVSU can no longer issue a refund if this form is not used to obtain your plate.

How to get your new plate:

Take this completed form to your nearest Secretary of State

OR

Compile and send the following to alumni@svsu.edu or to our office:

- a completed Appointment of Agent Form (see back)
- a photocopy of the front and back of your driver's license
