

SVSU License Plate Order Form

When you purchase an SVSU license plate, the SVSU Alumni Office covers the \$35 cost to replace your plate! An annual \$10 fee is added to your vehicle registration for renewing the SVSU fundraising license plate. The \$10 supports the SVSU Legacy Program to give more students access to attend SVSU.

Only the vehicle's registered owner has the authorization to change the license plate. Your new plate will arrive by mail within 4-6 weeks after the Secretary of State receives it. Please note that SVSU can no longer issue a refund if this form is not used to obtain your plate.

How to get your new plate:

Take the form to the Secretary of State yourself

 Take this completed form (front and back) to your nearest Secretary of State

Compile and send the following to <u>alumni@svsu.edu</u> or to our office:
