In compliance with the U.S. Department of Education Drug Free Schools and Campuses Act and Amendments, a biennial review of the Saginaw Valley State University (SVSU) Alcohol and Other Drug (AOD) program was conducted in January 2025.

Part 86, the Drug-Free Schools and Campuses Regulations, requires that, as a condition of receiving funds or any other form of financial assistance under any federal program, an institution of higher education (IHE) must certify that it has adopted and implemented a program to prevent the unlawful possession, use, or distribution of illicit drugs and alcohol by students and employees.

This Biennial Review complies with the mandate set forth by the Drug-Free Schools and Campuses Act and Amendments. The objectives of this Biennial Review include:|

- To determine the effectiveness of, and to implement any needed changes to, the Alcohol and Other Drug program;

I. Program Statement, Goals and Elements

A. SVSU has adopted and implemented a program to maintain an environment free from the unlawful manufacture, distribution, dispensation, possession or use of controlled substance and/or alcohol. SVSU is striving to create a program that complies with the Drug-Free Schools and Campuses Regulations. SVSU is aware of the following key elements:

- Preparing a written policy on alcohol and other drug possession, use and/or distribution;
- Developing a sound method of distribution of the policy to every student and staff member each year; and
- Preparing a biennial review on the effectiveness of its AOD programs and enforcement.

B. Program Goals: The following goals have been established by SVSU as critical to the success and impact of the AOD program:

- Assess campus attitudes toward the use of alcohol and other drugs.
- Promote campus resources regarding alcohol education, assessment and assistance.
- Educate faculty and staff on how to identify alcohol/drug-influenced behaviors through Faculty Association meetings, Classroom visits by Mental Health & Wellness Center Staff, and through the distribution of the Guide to Working with Distressed or Disruptive Students Pamphlet.
- Communicate alcohol and drug information through orientations, freshman programs, leadership training, registered student organizations, the Greek community, student athletes and learning communities.
- Promote and educate the campus community on alcohol/drug regulations and sanctions for violations:
 - o Distribute publications annually and methodically that outline specific alcohol/drug information, resources and regulations for students, staff and faculty.
 - o Develop residential life policies, substance-free locations and resident education programs that promote healthy choices and ensure accountability.
- Develop program initiatives for responsible, healthy alternatives to alcohol and drug use.
- Promote campus events as an alternative to alcohol choices.
- Sponsor Valley Night through Program Board opportunities.
- Assess programming options and availability, as well as resources.
- Establish an ongoing system of evaluating AOD policies, programs and outcomes through an ad hoc committee of relevant stakeholders.
- Maintain ongoing records and data of AOD programs and violations.

II. Policy

III. Distribution of Information

- A. A strategic approach to the distribution of the AOD policy and programs for enrolled students is in place and begins with the student's application to SVSU. Information continues to be provided through the orientation process, which includes annual comprehensive notification to all new freshmen and transfer students and an e-mail notification with a link to the policy and supporting resources to all students biannually. - B. Drug-Free Workplace and Substance Abuse Policy and Regulations are linked on the employee website for all faculty and staff. The policies are included in the University's Operations Manual. New employees are notified of the policies and their obligation to be familiar with the content. The policies are part of the new employee on-boarding procedures.

V. Intervention and Enforcement

Expectations for behavior relative to alcohol/other drugs is clearly communicated and enforced at SVSU. The offices of Residential Life, Mental Health & Wellness Center, Student Conduct Programs and University Police work closely to ensure that the University is responding appropriately when dealing with students struggling with alcohol- or drug-related personal issues. At the same time, the continuum of sanctions is closely enforced and students who exhaust the opportunity to find solutions to the choices they make relative to alcohol/drug behaviors, are removed from housing and/or enrollment, as prescribed.

VI. Evaluation

SVSU's Alcohol/Other Drug Policy and Programs are evidence-based. The University relies on attitudes and behaviors of its students to develop and implement the various components of alcohol and drug awareness. The University will explore options to gather more recent data.

Local data compiled by conduct and counseling personnel are maintained and considered in recommending revisions to practices relevant to the AOD program. The policy is reviewed annually, with changes examined by the Office of General Counsel and approved by SVSU's President.

An ad-hoc committee, consisting of members from Mental Health & Wellness Center, Human Resources, Peer Health Educators, Student Conduct Programs, University Police and the Student Body, has been formed to review SVSU's Biennial Review.

VII. Recommendations for Change

Students:

- Continue to ensure that an annual review of policy and practices is conducted, including appropriate stakeholders (i.e. student leadership, administration).
- Continue to sponsor Valley Nights through Program Board (Thursday, Friday, Saturday events).
- Continue to enhance peer mentoring through peer health educators.
- Monitor legal updates and revise policies and procedures accordingly.
- Explore options to gather data related to alcohol and drug use at SVSU.

Employees:

- Human Resources will distribute the Drug-Free Workplace Policy 4.3-2 annually.
- In consultation with supervisors, identify or develop supervisor and workforce training about the dangers and signs of drug and/or alcohol abuse by employees.
- Monitor legal updates and revise policies and procedures accordingly.
