 - Fieldwork reflections should be submitted after the final fieldwork visit and should demonstrate connections between course readings and fieldwork observations for:
 - Physical Environment: classroom and outdoor play
 - Social Environment: teacher-student interactions and peer relationships
 - Daily Routines and Procedures: classroom management and curricular schedule;
 - Course Reading activities may include comprehension activities such as Illustrating for Comprehension, Making Connections, Gimme 5, etc.

☐ Criteria #3:

- Facilitation of a Child-Based Assessment that documents a single-child's progress through age-related milestones across all major domains of development (Gross Motor, Fine Motor, Language, Cognition, Social/Emotional, and Self Help)
 - Evidence should be recorded in fact-based observation notes
 - Analysis of observation notes should lead to general conclusion/recommendation (i.e. development exceeds expectation, meets expectation, or requires support).
